- (a) absolutely, unconditionally and irrevocably terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to, and right to set off against, the right, title, and interest in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing, including, but not limited to, the foregoing listed on Schedule A attached hereto;
 - (b) represents and warrants that it has full authority to execute and deliver this Release; and
 - (c) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
