STATEMENT REGARDING OWNERSHIP

The undersigned represents Free Hand, LLC, the applicant for the subject trademark application. The undersigned filed the subject trademark application on behalf of Free Hand, LLC and has been the attorney of record at all times during the pendency of this application through the present date. Free Hand, LLC has been the lawful owner of the subject trademark application at all times through the present date.

On August 28, 2012, the undersigned filed a change of name document for recordation in connection with the subject trademark application, as well as with USSN 85/195,767. The change of name document should have been filed only for the latter application. Inclusion of the subject trademark application on the Cover Sheet was erroneous.

The change of name document indicated that the owner of the trademark applications had changed its name from Bedrock Manufacturing Comapny, LP [*sic*] to Bedrock Holdings, LP. A copy of the Cover Sheet is attached. The document was recorded at reel/frame 4850/0721. The change of name information was correct only for USSN 85/195,767 and not for the subject trademark application. The USPTO records currently indicate that the owner of the subject trademark application is Bedrock Holdings, LP, which is false.

The undersigned also represents Bedrock Holdings, LP (fka Bedrock Manufacturing Company, LP) in trademark matters, and is the attorney of record for USSN 85/195,767.

The undersigned does solemnly swear under penalty of perjury that:

- 1) Free Hand, LLC has never conveyed any interest in the subject trademark application, in whole or in part, to Bedrock Manufacturing Company, LP, or to any other entity;
- 2) Free Hand, LLC always has been and does so remain the rightful owner of the subject trademark application;
- 3) The change of name document submitted for recordation on August 28, 2012 in connection with the subject trademark application, and recorded at reel/frame 4850/0721, was submitted in error;
- 4) There is no proper chain of title from Free Hand, LLC to either Bedrock Manufacturing Company, LP or to Bedrock Holdings, LP; and
- 5) The USPTO records should be updated to correctly reflect the proper and rightful owner of the subject trademark application as Free Hand, LLC.
