NUNC PRO TUNC TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of the foregoing, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor has sold, assigned, transferred and conveyed, and does hereby sell, assign, transfer and convey to Assignee, its successors, legal representatives and assigns, all right, title and interest in and to the Trademarks, including without limitation: (i) all common law rights therein; (ii) all goodwill associated therewith and symbolized thereby; (iii) the right to sue for and be awarded past damage for infringement of the Trademarks and (iv) the right to further assign and/or to license any and all right, title and interest in and to the Trademarks.
