## ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS AGREEMENT is made this 20<sup>th</sup> day of September, 2011 by and between Smartwool LLC ("Assignor"), a Colorado limited liability company, having its principal office at 3495 Airport Circle, Steamboat Springs, Colorado 80202 and TBL Licensing LLC ("Assignee"), a Delaware limited liability company, having a registered address c/o Corporation Service Company, 2711 Centerville Road, Suite 400, Wilmington, Delaware 19808.

### RECITALS:

WHEREAS, Assignee is the sole member of Assignor;

WHEREAS, Assignor has approved a distribution to Assignee of all right, title and interest in Assignor's intangible property in existence as of the date of the distribution (the "Distribution"), including all intellectual property (including trademarks, copyrights, patents, and trade secrets), wholesale customer relationships, customer backlog, licensing agreements; distributor agreements, product development, know how, goodwill and going concern value; and

WHEREAS, Assignee desires to accept the Distribution and receive all right, title, and interest in and to the distributed intangible property, including all intellectual property (including trademarks, copyrights, patents, and trade secrets), wholesale customer relationships, customer backlog, licensing agreements; distributor agreements, product development, know how, goodwill and going concern value (the "Intangible Property").

NOW, THEREFORE, in consideration of the Distribution and the mutual covenants contained herein, the sufficiency and receipt of which are hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:

### WITNESSETH:

1. *Assignment.* Assignor hereby assigns, transfers, and conveys to Assignee all of Assignor's right, title, and interest in and to the Intangible Property, including all trademarks, service marks, and trade names and the applications for registration thereof shown on the attached Schedule 1 and any unregistered and/or common law trademarks (collectively, the "Marks") and the goodwill of the business symbolized by the Marks.

2. *Acceptance.* Assignee hereby accepts the foregoing assignment and expressly assumes any and all liabilities, debts and obligations associated with the Intangible Property.

3. *Non-competition Agreement.* In connection with the foregoing assignment, Assignor agrees that it will not directly or indirectly use the employees and tangible assets associated with the historic business of Smartwool for a period of 10 years from the date of this Agreement. Nevertheless, Assignee acknowledges and agrees that Assignor may use the employees and tangible assets associated with the historic business of Smartwool to engage in such business if Assignor and Assignee enter into a licensing agreement whereby Assignee grants Assignor the right to use the Intangible Property (including intellectual property and goodwill) relating to the historic business of Smartwool (the "IP Licensing Agreement"). Assignor and Assignee anticipate the contemporaneous execution of such IP Licensing Agreement.

4. *Further Assurances.* The parties hereto shall cooperate fully with each other in any action required to be taken to fulfill their respective obligations hereunder, including, without limitation, the execution and delivery of any and all other instruments and papers and the taking of any and all additional actions that either party reasonably requests from time to time to effectuate the purposes and intent of this transaction and otherwise to consolidate, vest and record in Assignee, with the appropriate authorities, full and complete ownership of the Intangible Assets.

3. *Successors and Assigns.* This Agreement shall be binding upon, inure to the benefit of and be enforceable by the parties hereto and their respective successors and permitted assigns, and nothing in this Agreement, express or implied, is intended to or shall confer upon any other person any rights, interests, benefits or remedies of any nature whatsoever under or by reason of this Agreement.

4. *Counterparts.* This Agreement may be executed in one or more counterparts, and each such counterpart hereof shall be deemed to be an original instrument, but all such counterparts together shall constitute but one agreement.


