RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest (this “**Release**”) is dated as of December 20, 2012, and entered into by **U.S. BANK, NATIONAL ASSOCIATION**, as the Collateral Agent under the Agreement (as defined below) (in such capacity, together with its successors in such capacity, “**Collateral Agent**”), in favor of **NEW YORK-NEW YORK HOTEL & CASINO, LLC**, a Nevada limited liability company, as grantor (“**Grantor**”). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Agreement (defined below).

**WHEREAS**, reference is made to that certain Trademark Security Agreement dated as of November 14, 2008, between Collateral Agent and Grantor (as amended from time to time, the “**Agreement**”).

**WHEREAS**, the Agreement was duly recorded with the United States Patent and Trademark Office (“**USPTO**”) on November 14, 2008 at Trademark Reel 3888, Frame 0136.

**WHEREAS**, Collateral Agent now desires to terminate and release its security interest in and lien on the Collateral.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates, releases, and discharges fully its security interest in and lien on the Collateral (as defined in the Agreement) including that granted pursuant to the Agreement or any related agreement, and Collateral Agent reconveys, transfers, and assigns to Grantor and its successors and assigns any and all of Collateral Agent’s right, title and interest in and to the Collateral pursuant to or in connection with the Agreement or any related agreement, including, without limitation, all applications, registrations, and recordings including in such Collateral foregoing in the USPTO or in any similar office or agency of the United States, any State thereof, and any political subdivision thereof, or in any other countries, and all reissues, extensions, and renewals thereof, including, without limitations, those trademarks, terms, designs, and applications described in **Schedule 1**, together with all of the goodwill of the business connected with the use of any of the foregoing.

Notwithstanding anything contained herein, U.S. Bank National Association does not in any way release or discharge any party to the Agreement (each a “**Party**”), and no Party in any way releases U.S. Bank National Association, from any claim, cause of action, duty, or obligation, of any type whatsoever which is unrelated to the release of the Agreement and the satisfaction of the Notes (as defined in the Agreement).
