# RELEASE OF SECURITY INTEREST IN TRADEMARK

This RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Agreement"), dated as of this 20 day of December, 2012, is made by The Bank of New York Mellon Trust Company, NA, a New York banking institution, as collateral agent (the "Assignor"), in favor of ION Media Networks, Inc. WHEREAS, the Security Agreement was executed on December 30, 2005 and recorded in the U.S. Patent and Trademark Office on January 4, 2006 at Reel 3241/Frame 0869; and

WHEREAS, the Assignor has terminated and released its liens and security interests on all of Assignee's property.

NOW, THEREFORE, in consideration of the satisfaction of the security interest, and for other good and valuable consideration, the receipt of which is hereby acknowledged:

- 1. Assignor hereby releases any and all right, title and interest in all of the Trademark Collateral owned or held by the Assignees, including, but not limited to, the right to sue for past, present and future infringement or dilution thereof or for any injury to goodwill, and the proceeds thereof, and hereby reassigns such right, title and interest in such Trademark Collateral to the respective Assignees.
- 2. This Agreement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same instrument.
