RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of December 21, 2012 (“Effective Date”) by Wells Fargo Capital Finance, LLC, a Delaware limited liability company, in its capacity as agent for the Lender Group and the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (in such capacity, “Grantee”), in favor of **JDA SOFTWARE GROUP, INC.**, a Delaware corporation (“Grantor”).

WHEREAS, reference is made to that certain Credit Agreement dated as of March 18, 2011 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among the lenders identified on the signature pages thereof, Grantor and Grantee;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of March 18, 2011 (as amended, restated, supplemented, or otherwise modified from time to time, the “Trademark Security Agreement”), by and between Grantor and Grantee, Grantor granted to Grantee a security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 4, 2011 at Reel 004515, Frame 0058; and

WHEREAS, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule 1 hereto.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantor all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.
2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantor’s expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
