**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 27, 2012, from General Electric Capital Corporation, a Delaware corporation ("GE Capital"), in its capacity as administrative agent and collateral agent (in such capacities, together with its successors and permitted assigns, the "Agent"), in favor of Revenue Rescue, Inc., Intermedix Corporation, Advanced Data Processing, Inc., Intermedix Technologies, Inc., Medical Consultants, Inc. and EMSystems LLC (each, a "Grantor" and, collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, dated as of March 14, 2011 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Trademark Security Agreement, dated as of March 14, 2011 (the "First Trademark Security Agreement"), and the Trademark Security Agreement, dated as of October 31, 2011 (the "Second Trademark Security Agreement"), each in favor of the Agent, a Lien on and security interest in (the "Security Interest") was granted by each of the Grantors to the Agent in all of such Grantor's right, title and interest in, to and under certain Collateral identified in the Trademark Security Agreement (the "Trademark Collateral");

WHEREAS, the First Trademark Security Agreement was recorded with the Assignment Division of the USPTO on Reel 4499, Frame 0744 on March 17, 2011, and the Second Trademark Security Agreement was recorded with the Assignment Division of the USPTO on Reel 4663, Frame 0973 on November 21, 2011; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the First Trademark Security Agreement and the Second Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, the Agent hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement, the First Trademark Security Agreement and the Second Trademark Security Agreement.

2. Release of Security Interest. The Agent hereby (i) terminates, releases, and discharges its Security Interest in the Trademark Collateral, including, without limitation, the Trademarks and the Licenses listed in Exhibit I attached hereto, (ii) terminates the Security Agreement, the First Trademark Security Agreement and the Second Trademark Security Agreement and (iii) re-assigns to each Grantor any right, title and interest it may have in, to and under the Trademark Collateral. Any and all right, title, or interest of the Agent in, to and under such Trademark Collateral and all proceeds thereof, including, without limitation, any and all

causes of action which may exist by reason of infringement of the Trademark Collateral, shall hereby cease and become void.


3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by the Grantors to effect the release of the Security Interest in the Trademark Collateral contemplated hereby.

4. Governing Law. This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS shall be governed by and construed in accordance with the laws of the State of New York.


