**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 21st, 2012 ("Release"), is made by **BANK OF AMERICA, N.A.** (including as successor by merger to LaSalle Bank National Association), as Administrative Agent ("Administrative Agent") in favor of **KIDS LINE, LLC**, a Delaware limited liability company, **SASSY, INC.**, a Delaware corporation, **LAJOBI, INC.**, a Delaware corporation, **I & J HOLDCO INC.**, a Delaware corporation, and **COCALO, INC.**, a California corporation (each a "Borrower", and collectively, the "Borrowers").

WHEREAS, pursuant to that certain second Amended and Restated Security and Pledge Agreement dated as of August 8, 2011 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Borrowers party thereto and the Administrative Agent, and the Patent and Trademark Security Agreement, Amended and Restated Patent and Trademark Security Agreement, and Notices of Grant of Security Interest in Patents referenced by recordations on Schedule A attached hereto ("IP Security Agreements"), each Borrower granted to the Administrative Agent, for the benefit of the holders of the Secured Obligations, a continuing security interest in, any and all right, title and interest of such Borrower in, to, and under all the Trademark Collateral, Trademarks, Trademark Licenses, and Proceeds of the foregoing.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the holders of the Secured Obligations, and Borrowers agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreements.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the holders of the Secured Obligations, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Trademark Collateral, Trademarks, Trademark Licenses, and Proceeds of the foregoing, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(b) authorizes the recordation of this Release with the USPTO at Borrowers' expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the holders of the Secured Obligations, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
