RELEASE OF SECURITY INTEREST – INTELLECTUAL PROPERTY

This Release of Security Interest – Intellectual Property (this “Release”) is made as of December 21, 2012 by RBC Bank USA (“RBC”), in its capacity as agent (RBC in such capacity, “Agent”) for itself and the various other financial institutions (collectively, the “Lenders”) party from time to time to that certain Loan and Security Agreement dated as of November 16, 2009, as amended, in favor of Triad Digital Media, LLC (“Company”).

Recitals

1. The Company received certain financial accommodations from Agent and the Lenders, and in connection therewith Company entered into an Intellectual Property Security Agreement dated as of November 16, 2009 (the “Security Agreement”).

2. Pursuant to the Security Agreement, the Company pledged and granted to Agent a security interest in its intellectual property, including but not limited to, copyrights, patents and trademarks, owned at the time or acquired thereafter. The Agent presently has a lien filed on the intellectual property owned or licensed by the Company, including the trademarks identified on Schedule 1 to this Release (collectively, the “Property”).

3. The Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 004098/0038 on November 17, 2009.

4. The Agent wishes to release all interest that Agent may have in the Property.

Agreement

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates, releases and discharges any and all security interest and liens in the Property without recourse, representation or warranty other than that Agent has not assigned or encumbered any of Agent’s interest in the Property, all interest of Agent in the Property.
