TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of July 20, 2012, is among the undersigned (the "Grantors"), and LBC Credit Partners II, L.P., as agent for the Lenders ("Agent").

W I T N E S S E T H:

WHEREAS, pursuant to the terms of that certain Loan and Security Agreement, dated as of July 20, 2012 (as it may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), among FPG, LLC, an Illinois limited liability company (the "Borrower"), CLP FPG, Inc., a Delaware corporation ("Holdings") and the other guarantors from time to time party thereto (collectively with Holdings, the "Guarantors", and collectively with the Borrower, the "Obligors"), the financial institutions party thereto from time to time as lenders (collectively, "Lenders"), and Agent, pursuant to which the Lenders have agreed to extend credit and make certain financial accommodations to the Borrower;

WHEREAS, pursuant to the Loan Agreement, the Grantors granted to the Agent for the benefit of the Lenders a security interest in and continuing lien on, all of the Grantors' right, title and interest in, to and under all Collateral, including the Trademark Collateral (as defined below), in each case whether now owned or existing or hereafter acquired or arising and wherever located to secure the prompt and complete payment and performance in full when due, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, of all Obligations including the obligations of the Obligors under the Loan Agreement;

WHEREAS, the parties to the Loan Agreement contemplate and intend that, the Agent for the benefit of the Lenders shall have all rights of a secured party in and to the Trademark Collateral and any proceeds thereof, including, without limitation, if an Event of Default shall occur and be continuing, the right to exercise its remedies under the Loan Agreement in connection with all of the Grantors' right, title and interest in such Trademark Collateral; and

WHEREAS, pursuant to the Loan Agreement, the Grantors are required to execute and deliver this Agreement.

NOW, THEREFORE, in consideration of the premises and the agreements, provisions and covenants herein contained, the Grantors agree as follows:

Section 1. Defined Terms

Unless otherwise defined herein, capitalized terms used herein have the meanings given to them in the Loan Agreement.

Section 2. Grant of Security Interest in Trademarks

The Grantors hereby grant to Agent for the benefit of the Lenders a security interest in and continuing lien on, all of the Grantors' right, title and interest in, to and under the Trademarks to the extent included in the Collateral, including but not limited to the Trademarks listed in Schedule A, in each

case whether now owned or existing or hereafter acquired or arising and wherever located (collectively, the "Trademark Collateral").

Section 3. Security for Obligations

This Agreement secures, and the Trademark Collateral is collateral security for, the prompt and complete payment or performance in full when due, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise (including the payment of amounts that would become due but for the operation of the automatic stay under Section 362(a) of the Bankruptcy Code, 11 U.S.C. §362(a) (and any successor provision thereof)), of all Obligations.

Section 4. Security Agreement

The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to the Agent for the benefit of the Lenders, pursuant to the Loan Agreement and the Grantors hereby acknowledge and affirm that the rights and remedies of the Lenders with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any irreconcilable conflict between the terms of this Agreement and the terms of the Loan Agreement, the terms of the Loan Agreement shall control.

Section 5. Recordation

The Grantors hereby authorize and request that the Commissioner of Patent and Trademarks and any other applicable United States government officer record this Agreement.

Section 6. Miscellaneous

This Agreement shall be governed by, and construed in accordance with the laws of the State of New York.

This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single agreement.

Section 7. Intercreditor Agreement


Notwithstanding anything herein to the contrary, the Agent, each Lender and each Grantor acknowledges that the Lien and security interest granted to Agent for the benefit of the Lenders pursuant to this Agreement and the exercise of any right or remedy by Agent for the benefit of the Lenders under this Agreement are subject to the provisions of the Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and this Agreement, the terms of the Intercreditor Agreement shall govern and control.




