### CONFIRMATORY GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS CONFIRMATORY GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Agreement") made as of this 18th day of January, 2013 by MIWD HOLDING COMPANY LLC, a Delaware limited liability company, HOMERITE IMPROVEMENTS, INC., a Florida corporation, GENERAL ALUMINUM HOLDINGS, LLC, a Delaware limited liability company, GENERAL ALUMINUM COMPANY OF TEXAS, LP, a Texas limited partnership, GENERAL ALUMINUM CORPORATION, a Delaware corporation, GENERAL ALUMINUM SALES & SERVICE, L.L.C., a Texas limited liability company, MI WINDOWS AND DOORS, INC., a California corporation, MI TRANSPORTATION, INC., a Florida corporation, and PROPLASTIX INTERNATIONAL, INC., a Florida corporation (collectively, the "Grantors" and each individually referred to as a "Grantor"), in favor of MANUFACTURERS AND TRADERS TRUST COMPANY, in its capacity as administrative agent and collateral agent (in such capacity "Agent"), for the financial institutions (collectively, the "Lenders") which are now or which hereafter become a party to the Loan Agreement (as defined below):

### WITNESSETH

WHEREAS, Grantors (collectively, the "Borrowers"), Lenders and Agent are parties to that certain Loan and Security Agreement of even date herewith (as same may be amended, restated, supplemented or modified from time to time, the "Loan Agreement",) providing for the extensions of credit to be made to Borrowers by Agent and Lenders;

WHEREAS, Borrowers have granted to Agent, for the benefit of Lenders, a security interest in substantially all of the assets of Borrowers including all right, title and interest of Borrowers in, to and under all now owned and hereafter acquired trademarks, together with the goodwill of the business symbolized by Borrowers' trademarks, and all products and proceeds thereof, to secure the payment of all amounts owing by Borrowers under the Loan Agreement and the Other Documents:

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

- 1. <u>Incorporation of Loan Agreement</u>. The Loan Agreement and the terms and provisions thereof are hereby incorporated herein in their entirety by this reference thereto. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Loan Agreement.
- 2. Grant and Reaffirmation of Grant of Security Interests. To secure the payment and performance of the Obligations, each Grantor hereby grants to Agent, for its benefit and the benefit of Lenders, and hereby reaffirms its grant pursuant to the Loan Agreement, of a continuing security interest in such Grantor's entire right, title and interest in and to the following whether now owned or existing or hereafter created, acquired or arising:
  - (i) each trademark listed on <u>Schedule I</u> annexed hereto and each patent listed on <u>Schedule II</u> (such trademarks and patents referred to as the "<u>Trademarks</u>" and "<u>Patents</u>," respectfully), together with any reissues, continuations or extensions

thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

- (ii) all products and proceeds of the forgoing, including without limitation, any claim by any Grantor against third parties for past, present or future (a) infringement or dilution of any trademark or patent, or (b) injury to the goodwill associated with any trademark.
- 3. <u>Covenants</u>. Each Grantor agrees not to sell, license, grant any option, assign or further encumber its rights and interests in the Trademarks or Patents without prior written consent of Agent.
- 4. Rights and Remedies; Power of Attorney. Each Grantor hereby covenants and agrees that, upon the occurrence and during the continuance of an Event of Default under the Loan Agreement, Agent, as the holder of a security interest under the Uniform Commercial Code for the benefit of Lenders, as now or hereafter in effect in the State of New York, may take such action permitted under the Loan Agreement, the Other Documents and/or permitted by law, in its exclusive discretion, in connection with the Trademarks and/or Patents covered hereby. Each Grantor hereby authorizes and empowers Agent, its successors and assigns, and any officer or agent of Agent as Agent may select, in its exclusive discretion, as such Grantor's true and lawful attorneyin-fact, upon the occurrence and during the continuance of an Event of Default, with the power to endorse such Grantor's name on all applications, assignments, documents, papers and instruments necessary for Agent, to use the Trademarks and/or the Patents or to grant or issue any exclusive or non-exclusive license under the Trademarks and/or the Patents to anyone else, or necessary for Agent to assign, pledge, convey or otherwise transfer title in or dispose of the Trademarks and/or the Patents to anyone else. Each Grantor hereby ratifies all that such attorney shall lawfully do or cause to be done by virtue hereof and in accordance with the terms hereof. This power of attorney shall be irrevocable for the life of this Agreement, the Loan Agreement and the Other Documents, and until the Loan Agreement has been terminated and all of the Obligations, other than unasserted and unknown contingent indemnification obligations and obligations in respect of Bank Products thereunder, have been paid and performed in full.
- 5. Rights and Remedies not Exclusive. The enumeration of the foregoing rights and remedies is not intended to be exhaustive and the exercise of any rights or remedy shall not preclude the exercise of any other right or remedies provided for herein or otherwise provided by law, all of which shall be cumulative and not alternative.
