**AMENDMENT OF
SECURITY INTEREST IN TRADEMARKS**

THIS AMENDMENT OF SECURITY INTEREST IN TRADEMARKS (this "**Amendment**"), dated as of February 19, 2013 (the "**Effective Date**"), is made by and between DEUTSCHE BANK AG NEW YORK BRANCH (the "**Former Administrative Agent**"), BANK OF AMERICA, N.A. (the "**Current Administrative Agent**"), SABRE HOLDINGS CORPORATION ("**Holdings**"), SABRE, INC. (the "**Borrower**"), and certain Subsidiaries of the Borrower (the "**Grantors**") (collectively, the "**Parties**").

WITNESSETH:

WHEREAS, Grantors entered into that certain Pledge and Security Agreement dated as of March 30, 2007 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**") with Former Administrative Agent.

WHEREAS, Grantors entered into that certain Trademark Security Agreement dated as of March 30, 2007 with the Former Administrative Agent, as amended and restated by the Amended and Restated Trademark Security Agreement of March 6, 2009 (the "**Trademark Security Agreement**"), which was recorded at the United States Patent and Trademark Office at, without limitation, Reel 3947, Frames 0411, 0702, 0738, 0776, 0787, 0801, 0834, 0845, and 0891.

WHEREAS, Grantors entered into certain supplemental trademark security agreements with the Former Administrative Agent, which were recorded at the United States Patent and Trademark Office (the "**Supplemental Trademark Security Agreements**") at, without limitation, Reel 4193, Frames 0827 and 0848, and Reel 4775, Frames 0754 and 0767.

WHEREAS, Grantors granted the Former Administrative Agent, under the terms of the Security Agreement, Trademark Security Agreement, and all Supplemental Trademark Security Agreements, a continuing security interest (the "**Security Interest**") in favor of the Former Administrative Agent, in and to certain of Grantor's Intellectual Property, including without limitation the Trademark Collateral scheduled below.

WHEREAS, the Parties now desire to replace the Former Administrative Agent with the Current Administrative Agent.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Parties acknowledge that:

A. Definitions. Unless otherwise defined herein, terms used in this Amendment, including its preamble and recitals, have the meanings provided in the Security Agreement or the Trademark Security Agreement, as applicable.

B. Amendment of Security Interest. The "Administrative Agent" under the Trademark Security Agreement and the Supplemental Trademark Security Agreements shall be the Bank of America, N.A.

C. The Current Administrative Agent hereby assumes all rights, interest and obligations of the Former Administrative Agent in the Security Interest, pursuant to the Trademark Security Agreement, and the Former Administrative Agent relinquishes all rights, interest and obligations with respect to this Security Interest in favor of the Current Administrative Agent. This Security Interest and all supplements to this Security Interest going forward shall be administrated by Current Administrative Agent.


D. This Amendment may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Amendment by signing and delivering one or more counterparts.

E. This Amendment shall be governed by, and construed in accordance with, the law of the State of New York.






