INTELLECTUAL PROPERTY ASSIGNMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT** (this "IP Assignment"), dated as of January 28, 2013, is made by Jackson MSC LLC, a Delaware limited liability company (the "Company"), in favor of Jackson MSC, Inc., a Georgia corporation ("Buyer"), pursuant to the terms and conditions of that certain Asset Purchase Agreement, dated even herewith (as amended from time to time, the "Purchase Agreement"), among The Manitowoc Company, Inc., a Wisconsin corporation and ultimate parent company of the Company ("Parent"), Buyer and Hoshizaki USA Holdings, Inc., a Georgia corporation and parent company of Buyer.

Under the terms of the Purchase Agreement, Parent has agreed to cause the Company to sell, convey, assign, transfer and deliver to Buyer, among other assets, certain intellectual property of the Company, and has agreed to cause the Company to execute and deliver this IP Assignment, for recording with national, federal and state government authorities including, but not limited to, with respect to individual patents, registered trademarks and copyrights, applications for the foregoing and exclusive copyright licenses, the United States Patent and Trademark Office and the United States Copyright Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Company hereby sells, conveys, assigns and transfers to Buyer all of the Company's right, title and interest throughout the world in and to the following (collectively, the "IP Assets"):

- (a) the patents and patent applications set forth in Schedule 1 hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals thereof (the "Patents");
- (b) the trademark registrations and applications set forth in Schedule 2 hereto, together with the goodwill symbolized thereby and all issuances, extensions and renewals thereof (the "Trademarks");
- (c) the copyright registrations, applications for registration and exclusive copyright licenses set forth in Schedule 3 hereto and all issuances, extensions and renewals thereof (the "Copyrights");
- (d) the domain name *www.jacksonmsc.com*,
- (e) all rights of any kind whatsoever of the Company accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
- (f) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

- (g) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

The Company authorizes the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other national, federal and state government officials to record and register this IP Assignment upon request by Buyer.

The provisions of this IP Assignment are subject, in all respects, to the terms and conditions of the Purchase Agreement, including, without limitation, all of the covenants, representations and warranties contained therein, all of which shall survive the execution and delivery of this instrument to the extent indicated in the Purchase Agreement. Nothing contained in this instrument shall be deemed to modify, amend or supersede any of the terms or conditions of the Purchase Agreement. In the event of any conflict or inconsistency between the terms and conditions of this instrument and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall prevail. This instrument shall be binding upon the Company and its successors and assigns, and shall inure to the benefit of Buyer and its successors and assigns.
