**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of March 28, 2013 (this "Termination and Release"), from JPMORGAN CHASE BANK, N.A., as the applicable first lien representative (the "Agent") for the Secured Parties to MOMENTIVE SPECIALTY CHEMICALS INC. (f/k/a HEXION SPECIALTY CHEMICALS, INC.) and MOMENTIVE SPECIALTY CHEMICALS INVESTMENTS INC. (the "Pledgors").

WITNESSETH:

WHEREAS, pursuant to the Third Amended and Restated Collateral Agreement dated as of January 29, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") among the Pledgors, certain of its affiliates as identified therein and the Agent, a security interest (the "Security Interest") was granted by the Pledgors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to the Collateral Agreement the Pledgors entered into the Trademark Security Agreements dated January 29, 2010, June 30, 2010, November 11, 2010, March 17, 2011, April 1, 2011, July 1, 2011, October 1, 2011, June 30, 2012 and December 31, 2012 among the Agent and the Pledgors (each, as amended, restated supplemented or otherwise modified from time to time, the "Security Agreements");

WHEREAS, the Security Agreements were recorded in the Trademark Division of the United States Patent and Trademark Office on February 5, 2010 at Reel 004145 and Frame 0073, September 27, 2010 at Reel 004284 and Frame 0593, January 11, 2011 at Reel 004450 and Frame 0776, April 22, 2011 at Reel 004527 and Frame 0379, , April 29, 2011 at Reel 004531 and Frame 0553, November 18, 2011 at Reel 004663 and Frame 0149, November 18, 2011 at Reel 004663 and Frame 0511 and July 27, 2012 at Reel 004829 and Frame 0001, and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement and the Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Collateral Agreement. The term "Trademark Collateral," as used herein, shall mean all of the Pledgors' right, title and interest in or to the Trademarks, including those listed on Schedule A hereto.


2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
