



WHEREAS, by a certain Grant of Security Interest in Trademark Rights (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Agreement**"; terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Agreement) effective as of May 29, 2009 by Sealy Technology LLC, a North Carolina limited liability company, located at One Office Parkway, Trinity, NC 27370 (the "**Grantor**"), in favor of JPMORGAN CHASE BANK, N.A., as Collateral Agent (the "**Agent**") for the several banks and other financial institutions (the "**Lenders**"), parties to the Credit Agreement, dated as of May 13, 2009 (as amended, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among Sealy Mattress Company, an Ohio corporation (the "**Borrower**"), Sealy Corporation, a Delaware corporation, Holdings, the Lenders and the Agent, the Administrative Agent and the Co-Collateral Agent, which Agreement was recorded with the United States Patent and Trademark Office (the "**USPTO**") on June 4, 2009 on reel 4001 frame 0699, Grantor pledged and granted to the Agent for the benefit of the Secured Parties, a continuing security interest in all of the Grantor's right, title and interest in, to and under the Trademarks (including, without limitation, each Trademark registration and application therefor, referred to in Schedule A hereto, and all of the goodwill of the business connected with the use of or symbolized by, each Trademark) (collectively, the "**Trademark Collateral**"), to the Agent for the benefit of the Agent and the Secured Parties to secure payment, performance and observance of the Obligations.

WHEREAS, the Agent has agreed at the request of the Grantor to release its security interest in and lien on the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

SECTION 1. Release of Security Interest in Trademark Collateral.

(a) In accordance with the instructions of the Company received pursuant to Section 1403 of the Indenture, the Agent hereby terminates the Agreement and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademark Collateral.

(b) If and to the extent the Agent has acquired any right, title or interest in, to or under any of the Trademark Collateral, the Agent hereby assigns, transfers, conveys and delivers such right, title or interest to the Grantor.

(c) The Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release of Security Interest in Trademark Rights, in each case at the Grantor's sole expense.

SECTION 2. *Recordation of Release.* The Agent hereby authorizes and requests that the Commissioner for Trademarks in the USPTO, and any other necessary United States government officer, record this Release of Security Interest in Trademark Rights; it being understood that such recordation shall be at the Grantor's sole expense.

SECTION 3. *Counterparts.* This Release of Security Interest in Trademark Rights may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.


SECTION 4. *Governing Law.* This Release of Security Interest in Trademark Rights shall be governed by and construed in accordance with the laws of the State of New York.




