BILL OF SALE AND ASSIGNMENT

THIS BILL OF SALE AND ASSIGNMENT ("Bill of Sale"), dated this 12th day of October, 2012, is from KS MARINE PRODUCTS, INC., d/b/a Keel Shield, an Illinois corporation (hereafter "Seller") to SS MARINE PRODUCTS, INC., an Illinois corporation (hereafter "Buyer").

WITNESSETH:

In consideration of the sum shown below, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. *Sale and Transfer of Assets.* Seller does hereby sell, assign, transfer, bargain, deliver and confirm unto Buyer, and to any and successors and assigns forever, all of Seller's right, title and interest in and to the following assets of Seller (such assets being listed and collectively referred to as "Acquired Assets"):

- a) [REDACTED] for all shop and office equipment of Seller currently located at the Keel Shield facility at Farmington, Illinois excepting one computer tower unit to be kept by Seller;
- b) [REDACTED] Seller's total cost of all of Seller's inventory as it currently exists at the Keel Shield facility at Farmington, Illinois, or other areas where materials and equipment may be stored pursuant to Seller's inventory conducted on October 9, 2012; and
- c) [REDACTED] for all intellectual property including any and all rights to patents, trademarks, copyrights and trade names of Seller including, but not limited to KeelShield, BowShield, and SkegShield.

2. The parties note that, pursuant to the terms of their Asset Acquisition Agreement, Seller is not transferring or selling to Buyer, and Buyer is not acquiring Seller's accounts receivable or cash on hand as of the date of closing.

3. *Governing Law.* The Bill of Sale shall be governed by and construed and enforced in accordance with the laws of the State of Illinois, determined without reference to conflicts of law principles.


4. *Defined Terms.* Terms not otherwise defined herein shall have the meaning ascribed to such terms in the Asset Acquisition Agreement between the parties.
