**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of February 13, 2013 by BARCLAYS BANK PLC, as collateral agent for the Secured Parties (and, to the extent provided in Section 7.1 of the Pledge and Security Agreement (as defined below), the Debenture Trustee on behalf of the 2023 Debentures Holders) (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”) in favor of PVH Corp. (f/k/a Phillips-Van Heusen Corporation); Cluett, Peabody & Co., Inc.; Tommy Hilfiger Licensing LLC; and PVH Neckwear, Inc. (f/k/a PVH Superba/Insignia Neckwear, Inc.) (each, a “Trademark Grantor” and collectively, the “Trademark Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement.

**WHEREAS**, each Trademark Grantor executed and delivered to the Collateral Agent a U.S. Pledge and Security Agreement dated as of May 6, 2010 (the “Pledge and Security Agreement”);

**WHEREAS**, pursuant to the terms and conditions of (i) the Pledge and Security Agreement (ii) a Trademark Security Agreement dated as of May 6, 2010, which was recorded with the U.S. Patent and Trademark Office on June 4, 2010 at Reel/Frame numbers 4218/0705, 4219/0047, 4219/0246, and 4218/0785 (iii) a Trademark Security Agreement (First Supplemental Filing) dated as of September 27, 2011, which was recorded with the U.S. Patent and Trademark Office on October 5, 2011 at Reel/Frame numbers 4636/0018, and (iv) a Trademark Security Agreement (Second Supplemental Filing) dated as of July 25, 2012, which was recorded with the U.S. Patent and Trademark Office on August 7, 2012 at Reel/Frame numbers 4837/0552, 4837/0580 and 4837/0570, each Trademark Grantor granted to the Collateral Agent, for the benefit of the Secured Parties (and, to the extent provided in Section 7.1 of the Pledge and Security Agreement, the Debenture Trustee on behalf of the 2023 Debentures Holders), a security interest in and continuing lien on all of such Trademark Grantor’s right, title and interest in, to and under the following, in each case whether then owned or thereafter acquired and wherever located:

all United States and foreign trademarks, trade names, trade dress, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, whether or not registered, and with respect to any and all of the foregoing: (i) all registrations and applications therefor including, without limitation, the registrations and applications listed in Schedule A attached hereto, (ii) all extensions or renewals of any of the foregoing, (iii) all of the goodwill of the business connected with the use of and symbolized by any of the foregoing, (iv) all rights to sue or otherwise recover for any past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to the related goodwill, (v) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto, and (vi) all other rights of any kind accruing thereunder or pertaining thereto throughout the world (collectively, the “Trademark Collateral); and

**WHEREAS**, the Collateral Agent acknowledges full performance of all Obligations (and, to the extent provided in Section 7.1, the 2023 Debentures Obligations), and accordingly has agreed to release its security interest in and continuing lien on all of each Trademark Grantor’s right, title and interest in, to and under the Trademark Collateral.

**NOW, THEREFORE**, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases, relinquishes and discharges, with respect to each Trademark Grantor, its security interest in and continuing lien on all of such Trademark Grantor’s right, title and interest in, to and under the Trademark

Collateral, and retransfers and reassigns to such Trademark Grantor any right, title or interest the Collateral Agent may have in or to the Trademark Collateral, all without warranty or representation of any kind.
