RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of __April 16 __, 2013 ("Effective Date") by Wells Fargo Bank Northwest, N.A., a National Banking Association, in its capacity as Collateral Trustee, with its principal office at MAC U1240-026, 260 N. - (iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark license, in each case together with the right to sue for injunctive and other relief including collecting said damages;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on July 2, 2007, at Reel 003572, Frame 0370;

WHEREAS, Debtor has paid all of its outstanding indebtedness to Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests Secured Party has against the Trademark Collateral. Secured Party represents and warrants that it has the full power and authority to execute this Release and that it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral.
