**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of May 1, 2013 (“Effective Date”) by and between Reddy Ice Corporation, a Nevada corporation, (the “Grantor”) and Macquarie Bank Limited, an Australian entity as administrative agent (together with its successor(s), the “Administrative Agent”).

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Administrative Agent dated as of May 31, 2012 (the “Trademark Security Agreement”), Grantor pledged and granted to Administrative Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as such term is defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, in each case together with the goodwill associated therewith;

**WHEREAS**, Grantor and Administrative Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Credit Agreement dated May 31, 2012 (as amended, supplemented, amended and restated or otherwise modified from time to time) by and between Grantor and Administrative Agent (the “Credit Agreement”);

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 20, 2012 at Reel 004826, Frame 0276; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Administrative Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.

Administrative Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release, in each case solely at Grantor’s cost and expense.

Administrative Agent hereby authorizes Grantor to make such filing with the United States Patent and Trademark Office as may be reasonably determined by Grantor to be required to record and evidence the termination, cancellation, and release of the security interests in the Trademark Collateral evidenced hereby.
