THIS DEED is made on the 1st day of 50ne 2011.

BETWEEN:

- (1) CADBURY SCHWEPPES TREASURY INTERNATIONAL a company incorporated under the laws of the Republic of Ireland with registered number 237242 and having its registered office at c/o Cadbury Ireland Limited, Coolock, Dublin 5 ("CSTI"); and
- (2) KRAFT FOODS GLOBAL BRANDS LLC, a limited liability company established in the state of Delaware, U.S.A. with an office at Three Lakes Drive, Northfield, Illinois 60093, U.S.A ("KF Global Brands").

RECITALS:

- (A) CSTI is the legal and beneficial owner of the Intellectual Property (as defined below); and
- (B) CSTI has agreed with KF Global Brands to sell and assign the Intellectual Property to KF Global Brands, and KF Global Brands has agreed to purchase and accept such assignment.

IT IS AGREED as follows:

- 1. DEFINITIONS AND INTERPRETATION
- 1.1 "Effective Date" means 1 June 2011.
- 1.2 "Consideration Amount" means €23,173,478.67 (being the euro equivalent of USD\$32,082,900 at a EUR/USD exchange rate of 0.7223, as at 2 February 2010) exclusive of any applicable taxes to be satisfied by letter of direction executed on or around the date of this Deed between, inter alios, Kraft Foods Finance Europe AG, CSTI and KF Global Brands.
- 1.3 "Intellectual Property" means the registered and unregistered Intellectual Property Rights described in the Schedule to this Deed.
- "Intellectual Property Rights" means all patents, rights in inventions, rights in designs, trade marks, trade and business names and all associated goodwill, rights to sue for passing off or for unfair competition, copyright, moral rights and related rights, rights in databases, topography rights, domain names, rights in information (including know-how and trade secrets) and all other similar or equivalent rights in any part of the world, in each case whether registered or unregistered and including all applications (and rights to apply) for, and renewals or extensions of, such rights for their full term.
- 1.5 "Licence" means the Trade Mark Licence Agreement dated 31 March 2003 between CSTI (having been assigned from Cadbury Ireland Limited to CSTI by Deed of even date) and KF Global Brands (having been assigned from Cadbury Adams USA LLC to KF Global Brands with effect from 1 January 2011) licensing rights in some or all of the Intellectual Property.
- 1.6 References to this Deed include the recitals and Schedule which form part of this Deed for all purposes. References in this Deed to the parties, the recitals, Schedule and clauses are references respectively to the parties and their legal personal representatives, successors and permitted assigns, the recitals and Schedule to and clauses of this Deed.
- 1.7 The headings in this Deed are for convenience of reference only and shall not affect the interpretation of this Deed.

- 2. ASSIGNMENT OF THE INTELLECTUAL PROPERTY AND TERMINATION OF LICENCE
- 2.1 With effect from the Effective Date, in consideration for receipt of the Consideration Amount (the receipt and sufficiency of which is hereby acknowledged), CSTI hereby assigns to KF Global Brands absolutely all of its legal and beneficial right, title and interest in and to the Intellectual Property, together with the right to sue in respect of every act of infringement of the Intellectual Property occurring prior to the Effective Date, and the right for KF Global Brands to bring proceedings against any third party in relation to the Intellectual Property.
- 2.2 CSTI agrees to perform (or procure the performance of) all further acts and things, and execute and deliver (or procure the execution and delivery of) such further documents, as may be required by law or as KF Global Brands may reasonably require, whether on or after the Effective Date, to implement, or record the effect of, this Deed and the transactions contemplated by this Deed.
- 2.3 The parties acknowledge that KF Global Brands as current licensee under the Licence will, by virtue of this Deed, acquire ownership of the Intellectual Property Rights which are the subject of the Licence and accordingly that the Licence is redundant and is hereby terminated by mutual agreement of the parties with effect from the Effective Date.

3. GENERAL

- 3.1 The parties warrant to each other that they each have full power and authority to enter into this Deed, which constitutes legal obligations which are valid and binding on them in accordance with their terms, and that they each have full power and authority to perform those obligations.
- 3.2 Neither party shall assign or transfer its rights or obligations under this Deed except with the prior written approval of the other party; provided, however, that both parties may assign or transfer its rights or obligations under this Deed to any member of the group of companies of which it forms part.
- 3.3 The parties hereto shall each perform such acts, execute and deliver such instruments and documents, and do all such other things as may be reasonably necessary to complete the transactions contemplated in this Deed.
- 3.4 This Deed (together with any documents executed pursuant hereto) constitutes the whole agreement between the parties to this Deed.
- 3.5 All of the provisions of this Deed shall remain in full force and effect notwithstanding completion (except insofar as they set out obligations which have been fully performed at completion).
- 3.6 This Deed may be executed in one or more counterparts, and by the parties on separate counterparts, but shall not be effective until each party has executed at least one counterpart and each such counterpart shall constitute an original of this Deed but all the counterparts shall together constitute one and the same instrument.
- 3.7 No variation (or waiver of any provision or condition of this Deed) shall be effective unless it is in writing and signed by or on behalf of each of the parties (or, in the case of a waiver, by or on behalf of the party waiving compliance).
- 3.8 The construction, validity and performance of this Deed and all non-contractual obligations arising from or connected with this Deed shall be governed by Irish law.

Each party irrevocably agrees to submit to the exclusive jurisdiction of the courts of Ireland over any claim or matter arising under or in connection with this Deed and that accordingly any proceedings in respect of any such claim or matter may be brought in such court.
