**RELEASE OF SECURITY INTERESTS – TRADEMARKS**

**(Network Communications, Inc.)**

This RELEASE OF SECURITY INTERESTS – TRADEMARKS (this “Release”) is made and effective as of June 4, 2013 and is granted by Wells Fargo Capital Finance, Inc., acting in its capacity as Administrative Agent (“Releasor”), in favor of Network Communications, Inc., a Georgia corporation (the “Releasee”).

WHEREAS, the Releasee entered into the Amended and Restated Borrower Security Agreement, dated January 7, 2011 (the “Security Agreement”), in favor of Releasor, and the Trademark Security Agreement, dated January 7, 2011, the Trademark Security Agreement, dated July 20, 2007, and the Assignment of Security Interest and Amendment to Trademark Security Agreement dated January 7, 2011 (together, the “Trademark Security Agreements”) in favor of Releasor, pursuant to which, among other things, the Releasee granted to Releasor a continuing security interest in all of the Releasee’s right, title and interest in, to and under the Collateral, including the Trademark Collateral (as defined in the Security Agreement and the Trademark Security Agreements, respectively);

WHEREAS, the Trademark Security Agreements were recorded at the United States Trademark Office at Reel 004234/Frame 0356 on June 30, 2010, at Reel 004453/Frame 0307 on January 14, 2011, and at Reel 004453/Frame 0227 on January 14, 2011;

WHEREAS, the Releasee has requested that Releasor release and discharge fully its security interests in the all of the Trademark Collateral, including all registrations and applications therefor and all rights associated therewith; and

WHEREAS, as stated in, and subject to the terms and conditions set forth in, the Payoff Letter dated the date hereof by and between Releasor and Releasee, Releasor is willing to release and discharge fully its security interests in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Release of Trademark Collateral. Releasor hereby, without any representation or warranty and without any recourse of any kind to Releasor, releases, relinquishes and discharges its security interests in the Trademark Collateral, including the items listed on Schedule I hereto.

2. Further Assurances. Releasor agrees that, following the date hereof and at Releasee’s reasonable request, and at Releasee’s cost and expense, it will promptly execute and file, or cause to be filed, such further or other documents or instruments as are necessary or desirable to better evidence or otherwise further effect the foregoing release of its security interests in the Trademark Collateral.

3. Miscellaneous

(a) Governing Law. The validity of this Release, the construction, interpretation, and enforcement hereof, and the rights of the parties hereto with respect to all matters arising hereunder or related hereto shall be determined under, governed by, and construed in accordance with, the laws of the State of New York.

(b) Counterparts. This Release may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which shall be deemed to be an original, but all of which taken together shall constitute one agreement. Delivery of an executed counterpart of this Release by telefacsimile or other electronic method of transmission shall be equally as effective as delivery of an original executed counterpart of this Release. Any party delivering an executed counterpart of this Release by telefacsimile or other electronic method of transmission also shall deliver an original executed counterpart of this Release, but the failure to deliver an original executed counterpart shall not affect the validity, enforceability or binding effect of this Release.

(c) Severability. Any provision of this Release that is prohibited or unenforceable shall be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereof in that jurisdiction or affecting the validity or enforceability of such provision in any other jurisdiction.

(d) Headings. Headings used in this Release are for convenience only and shall not be used in connection with the interpretation of any provision hereof.


