SECURED PARTY BILL OF TRANSFER

This Secured Party Bill of Transfer (this "Bill of Transfer"), dated December [], 2011, is delivered in connection with the disposition, pursuant to the Uniform Commercial Code as enacted in the applicable jurisdictions (the "Code"), to Corsicana Bedding, Inc., a Texas corporation ("Buyer"), of all rights of International Bedding Corporation, a Delaware corporation ("Borrower"), Cleburne Bedding Corp., a Texas corporation and wholly-owned subsidiary of Borrower ("Cleburne"), and IBC of Pennsylvania, Inc., a Florida corporation and wholly-owned subsidiary of Borrower ("IBC Pennsylvania"; and collectively with Borrower and Cleburne, the "Companies") in the personal property listed on Exhibit A attached hereto (the Companies' interest in such property referred to herein as, the "Sale Property"); provided, however, the Sale Property shall expressly exclude: all cash and cash equivalent, bank accounts, accounts, payment intangibles, inventory, insurance claims and insurance policies, tax refunds, workers' compensation refunds, director and officer claims, commercial torts, claims or causes of action against the Agent or the Lenders, all claims and causes of action relating to the foregoing, all books and records relating to the foregoing (including all customer invoices, billing reports, customer correspondence), the accounts receivable billing system and related software, the assets listed on the attached Exhibit B, and any other property not capable of being subject to a security interest that may be perfected by filing a UCC financing statement. The Sale Property constitutes a portion of "Collateral" as such term is defined in and pursuant to (i) that certain Second Amended and Restated Credit Agreement dated as of June 27, 2008 (as amended or otherwise modified from time to time, the "Credit Agreement"; capitalized terms but not otherwise defined herein shall have the meanings assigned thereto in the Credit Agreement), by and among Madison Capital Funding LLC as Agent to the Lenders ("Seller"), Borrower and the lenders party thereto from time to time ("Lenders"), (ii) that certain Guarantee and Collateral Agreement dated as of April 12, 2005, by and between Agent, Lenders, and the grantors party thereto, and (iii) the other Loan Documents.

In consideration of Buyer's payment to Seller of ONE MILLION AND NO/100 DOLLARS (\$1,000,000), without offset, deduction or counterclaim, in immediately available funds, pursuant to 9-610 of the UCC Seller does hereby irrevocably sell to Buyer all of the Sale Property, free and clear of all liens and security interests of Seller and any other security interest or liens subordinate to Seller's security interest.

SELLER MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND WHATSEOVER WITH RESPECT TO THE SALE PROPERTY, INCLUDING, WITHOUT LIMITATION, ANY WARRANTY TO TITLE, POSSESSION, QUIET ENJOYMENT, MERCHANTABILITY BY ACCEPTANCE OF THIS BILL OF TRANSFER, BUYER OR THE LIKE. REPRESENTS AND WARRANTS THAT IT HAS NOT RELIED ON SELLER'S SKILL OR JUDGMENT TO SELECT OR FURNISH ALL OR ANY PORTION OF THE SALE PROPERTY FOR ANY PARTICULAR PURPOSE, THAT SELLER IS NOT A MANUFACTURER, DEALER OR MERCHANT IN THE SALE PROPERTY, THAT SELLER MAKES NO REPRESENTATIONS OR WARRANTIES REGARDING THE SALE PROPERTY, EXPRESSED, IMPLIED OR STATUTORY, AND THAT THIS BILL OF TRANSFER AND THE TRANSACTIONS CONTEMPLATED HEREBY ARE WITHOUT RECOURSE TO SELLER.

This Bill of Transfer shall be governed by the laws of Illinois (without giving effect to the principles of conflicts of law thereof).
