**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**May 21, 2013**

WHEREAS, pursuant to (i) that certain Trademark Security Agreement, dated as of August 22, 2008, recorded in the United States Patent and Trademark Office at Reel/Frame 003840/0408, (ii) that certain Amendment to Trademark Security Agreement, dated as of August 17, 2009, recorded in the United States Patent and Trademark Office at Reel/Frame 004064/0486 and (iii) that certain Copyright Security Agreement, dated as of August 17, 2009, recorded in the United States Copyright Office at Volume 3579 and Document No. D576 (together, the "IP Security Agreements"), HEALTHLAND, INC., previously known as DAIRYLAND HEALTHCARE SOLUTIONS, INC. a Minnesota corporation (the "Releasee") granted to SILICON VALLEY BANK ("Releasor"), a security interest in and to all of Releasee's right, title and interest in and to the following (collectively, the "IP Collateral"): (i) all of the Releasee's Trademarks, including those trademarks more fully identified on Schedule A annexed hereto and (ii) all of the Releasee's Copyrights, including those copyrights more fully identified on Schedule B annexed hereto; and

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreements.
2. Release of Security Interest. Releasor hereby, without any representation and warranty and without any recourse to Releasor, releases, relinquishes and discharges its security interest in the IP Collateral.
