INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment ("Assignment") is made and entered into as of February 28, 2013, by and between Danner, Inc., a Wisconsin corporation ("Assignor") and LaCrosse Footwear, Inc., a Wisconsin Corporation ("Assignee").

WHEREAS, Assignor has adopted, used and is using the Marks (as defined below), and owns all right title and interest in the Assets (as defined below); and

WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to the Assets;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Assignor acknowledges, the Assignor and Assignee hereby agree as follows:

1. Definitions. The capitalized terms used in this Assignment shall have the meanings specified in this Section 1, unless the context otherwise requires. The singular shall include the plural, and the masculine gender shall include the feminine gender and neuter, and vice versa, as the context requires.

- a) *Assets* – shall mean all Intellectual Property and all proceeds thereof, including, without limitation, any and all causes of action for infringement thereof and any and all royalties for any licenses thereof.
- b) *Intellectual Property* – shall mean all Marks, Patents and other intellectual property of Assignor, including, without limitation, any other (a) patents, patent applications, patent divisions, reissues, continuations, continuations-in-part, re-examinations and extensions, patent disclosures and improvements thereto; (b) registered or unregistered trademarks, service marks, trade dress, logos, trade names, fictitious business names and corporate names (including without limitation all brand names, trade style and similar designations of source or origin), and registrations and applications for registration thereof and all rights related thereto, including all good will; (c) registered or unregistered copyrights in published or unpublished works and registrations and applications for registration thereof; (d) domain names or uniform resource locators, including without limitation, all goodwill associated therewith and specifically including those domain names set forth on Schedule A hereto (e) computer programs, software, data, source code and related documentation owned by or licensed to Assignor, including that which relates to administrative, manufacturing and record-keeping functions whether or not related uniquely to Assignor's business; (f) trade secrets and confidential business information (including ideas, know-how, technical data, proprietary processes, copyrightable works, financial, marketing and business data, databases, pricing and cost information, business and marketing plans and customer and supplier lists and information and all other proprietary information); (g) license agreements or other rights related to the foregoing and any rights or causes of action and rights of recovery resulting from any past, present or future infringement or violation of any of the foregoing; and (h) any toll-free phone

numbers used in or related to Assignor's business; and any re-issue, continuation, continuation-in-part, division, improvement or extension thereof.

- c) *Marks* – shall mean those marks listed on Schedule B hereto, which may be registered in the U.S. Patent and Trademark Office and/or foreign trademark registration offices or may be the subject of pending applications as is detailed in Schedule B, and including all goodwill and common law rights associated therewith.
- d) *Patents* – shall mean the designs, inventions and patents listed in Schedule C hereto which may be registered in the U.S. Patent and Trademark Office and/or foreign patent registration offices or may be subject to pending applications as is detailed in Schedule C, and any patents which may be later obtained therefor or thereon.

2. Assignment. Assignor hereby assigns, transfers, and delivers to Assignee all of its rights, title and interest in and to the Assets, such Assets to be held and enjoyed by Assignee, for its own use, and for the use of its successors, assigns or other legal representatives to the full end of the term or terms for which the Intellectual Property may be granted, as fully and entirely as the same would have been enjoyed by the Assignor, had this Assignment not been made.

3. Intent of Parties. For purposes of clarifying the Assignor's intent, Assignor intends to assign to Assignee all right, title and interest in the Assets, so that Assignee may use such Assets, if desired, in Assignee's own business (directly or through subcontractors), in the same manner as Assignor previously used such Assets in its business. To the extent that such assignment of any of the Assets requires the consent of any third party, then Assignor hereby agrees to cooperate fully and promptly with Assignee to obtain such consent and, to the extent permitted by law, Assignee's assignment shall then be deemed effective as of the date first written above.

4. Price. In exchange for the Assets transferred hereunder, Assignee agrees to pay Assignor on the effective date of this Agreement and Assignor acknowledges receipt of, Two Million Four Hundred Twenty Thousand Dollars (\$2,420,000). Notwithstanding the foregoing agreement regarding price, the Assignor and Assignee agree that the Asset purchase price shall be adjusted to conform to any appropriate determinations made under and in accordance with applicable tax law.

5. Protection of Intellectual Property. Assignor and Assignee each agrees that the Assets as defined herein include all rights to sue, bring actions for and recover and hold damages, profits and other compensation for any and all past and future infringements and unauthorized uses of the Intellectual Property.

6. Further Assurances. Assignor also hereby covenants and agrees that Assignor shall, at the request of Assignee or its counsel, execute, acknowledge and deliver all such further acts, deeds, assignments, transfers, powers of attorney and assurances as may be required to carry out the intent of this Assignment, and to transfer and vest title to and in the Assets in Assignee, and to procure, maintain, enforce and protect the right, title and interest in and enjoyment of all of the Assets assigned, transferred and conveyed to Assignee pursuant to

this Assignment; provided, however, this Assignment shall be effective regardless of whether any such additional documents are executed.

7. Binding Effect. This Assignment shall be binding upon Assignor and Assignee and each of their respective successors and assigns, and upon all others acting by, through, with or under their direction or control, and all those in privity therewith.

8. Governing Law. The validity, performance, construction, interpretation, and effect of this agreement shall be governed by and construed in accordance with the internal laws of the State of Oregon (excluding its laws relating to conflicts of law).

9. Entire Agreement; Amendment. This Assignment and all attachments and additional documents incorporated by reference set forth the entire understanding and agreement of the parties with respect to the subject matter hereof and supersedes all prior understandings, negotiations, representations and writings relating thereto. No amendment or modification of any of the provisions of this Assignment will be binding unless made in writing and signed by both parties hereto.

10. Severability. If any provision of this Assignment, or the application thereof to any circumstance, person or place, shall be held by a court or other tribunal of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Assignment and such provisions as applied to other circumstances, persons or places shall remain in full force and effect. The parties also agree to perform such further acts and to execute and deliver such additional written instruments as may from time-to-time be reasonably required to carry out the intent, terms and conditions of this Assignment.

IN WITNESS WHEREOF, the Assignor and Assignee have each caused its duly authorized representative to execute and deliver this Assignment on its behalf as of the date first written above.


