TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 28, 2013, by U.S. BANK NATIONAL ASSOCIATION, in its capacity as Collateral Agent (in such capacity, "Collateral Agent").

WITNESSETH:

WHEREAS, Collateral Agent and Appvion, Inc., a Delaware corporation formerly known as Appleton Papers, Inc., along with Paperweight Development Corp., a Wisconsin corporation, American Plastics Company, a Wisconsin corporation, and New England Extrusion, Inc., a Wisconsin corporation (collectively "Grantors"), were parties to that certain Collateral Agreement, dated as of February 8, 2010 (the "Collateral Agreement") and the accompanying short-form agreement titled Trademark Collateral Agreement, pursuant to which Grantors granted a security interest to the Collateral Agent in certain trademarks and trademark applications (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantors to the Collateral Agent and certain other financial institutions, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Trademark Collateral Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on February 9, 2010, at Reel 4145, Frame 0402;

WHEREAS, Grantors have requested that the Collateral Agent release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Collateral Agent hereby absolutely, unconditionally and irrevocably releases and forever discharges its security interest in all of Grantors' right, title and interest under the Collateral Agreement, Trademark Collateral Agreement and any and all other security interests or liens that the Collateral Agent may have in and to the following (collectively the "Trademark Rights");

(i) each Trademark listed on Schedule 1 hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, the Trademarks; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark. Collateral Agent hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by

Collateral Agent, all of Collateral Agent's and its predecessors', successors' and assigns' right, title and interest in and to the Trademark Rights together with the goodwill associated therewith.

2. The Collateral Agent hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by the Collateral Agent, all of the Collateral Agent's right, title and interest in and to the Trademark Rights.
