RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY

AGREEMENT (this "Release") is made as of January 28, 2013 (the "Effective Date") by Bank of America, N.A., as collateral agent (in such capacity, the "Agent"), in favor of Vi-Jon, Inc. (the "Borrower") and each of the grantor parties identified on the signature page hereto (each, together with the Borrower, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of July 19, 2006, between the grantors party thereto and the Agent, (the "Trademark Security Agreement") and the Patent Security Agreement between the grantors party thereto and the Agent, dated as of July 18, 2006 (the "Patent Security Agreement" and, together with the Trademark Security Agreement, the "IP Security Agreements"), each of the Grantors pledged, assigned and granted to the Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, (a) the trademark registrations and applications set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the "Trademarks") and (b) the patents and patent applications set forth on Schedule II hereto (collectively, the "Patents");

WHEREAS, the Patent Security Agreement was recorded with the Patents Division of the U.S. Patent & Trademark Office on August 8, 2010, at Reel 018061 and Frame 0845;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, without any warranty or recourse of any kind, terminates the IP Security Agreements, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks and the Patents.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks and the Patents, it hereby re-assigns and re-transfers such rights, title or interest to their respective Grantors.

The Agent shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
