RELEASE OF SECURITY INTEREST IN TRADEMARKS

July 16, 2013

WHEREAS, QS WHOLESALE, INC., a California corporation (as successor by merger to Quiksilver Americas, Inc.), HAWK DESIGNS, INC., a California corporation, DC SHOES, INC., a California corporation, and MERVIN MANUFACTURING, INC., a California corporation (each individually, a "Grantor" and collectively, the "Grantors") granted a security interest (the "Security Interest") in certain Trademark Collateral to BANK OF AMERICA, N.A., a national banking association, as collateral agent (the "Collateral Agent"), as set forth in (i) that certain Trademark Security Agreement, dated as of October 27, 2010 by the Grantors in favor of the Collateral Agent (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the "2010 Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office on November 19, 2010, at Reel 004409 and Frame 0816 and (ii) that certain Trademark Security Agreement, dated on or about March 1, 2011 by certain Grantors in favor of the Collateral Agent (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the "2011 Trademark Security Agreement", and together with the 2010 Trademark Security Agreement, collectively, the "Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office on April 4, 2011, at Reel 004515 and Frame 0070. Capitalized terms used herein and not defined herein shall have the meanings assigned to such terms in the 2010 Trademark Security Agreement and the 2011 Trademark Security Agreement, as applicable;

WHEREAS, the Collateral Agent has been requested to release is Security Interest and reassign its interests in the Trademark Collateral including those Trademarks identified in Exhibit A attached hereto together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

(A) The Collateral Agent hereby terminates and releases the Trademark Security Agreement and fully discharges the Collateral Agent's Security Interest in the Trademark Collateral, including, but not limited to, the Trademarks identified in Exhibit A and all of the goodwill of the business connected with the use of, and symbolized by, such trademark and servicemark registrations and applications; and (ii) reassigns, transfers and conveys to the applicable Grantor, without any representation, warranty or recourse of any kind, any and all of the Collateral Agent's right, title and interest in and to the Trademark Collateral, effective as of the date set forth above.

(B) The Collateral Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given. The Collateral Agent shall, at the Grantors' sole cost and expense and at any of the Grantor's reasonable request, execute, acknowledge and deliver to the Grantors all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such Security Interest.

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
