FIRST AMENDMENT TO SUPPLEMENTAL SECURITY AGREEMENT

(Trademarks)

THIS FIRST AMENDMENT TO SUPPLEMENTAL SECURITY AGREEMENT (the "First Amendment") is made and dated as of the 12th day of July, 2013 (the "First Amendment Effective Date") by and between GENERAL ATOMICS AERONAUTICAL SYSTEMS, INC., a Delaware corporation (the "Borrower"), and BANK OF THE WEST, in its capacity as administrative agent to the Lenders party to the Credit Agreement referred to below (in such capacity, the "Administrative Agent").

RECITALS

- A. Pursuant to that certain Credit Agreement dated as of April 16, 2010 by and among the Borrower, Administrative Agent, the Lenders from time to time party thereto, the L/C Issuing Bank and the Swing Line Lender (as amended, extended and replaced from time to time, the "Credit Agreement," and with capitalized terms not otherwise defined herein used with the meanings given such terms in the Credit Agreement), the Lenders, the L/C Issuing Bank and the Swing Line Lender (the "Credit Providers") agreed to extend credit to the Borrower on the terms and subject to the conditions set forth therein. As a condition to the effectiveness of the Credit Agreement, the Borrower and the Administrative Agent entered into the Borrower Security Agreement (the "Security Agreement"), pursuant to which the Borrower has granted to the Administrative Agent on behalf of the Credit Providers a security interest in certain assets of Borrower, including, without limitation, all patents, trademarks, service marks, trade names, copyrights, goodwill, licenses and other intellectual property owned by Borrower or used in Borrower's business.
- B. The Borrower and the Administrative Agent supplemented the Security Agreement (the "Supplemental Trademark Agreement") as it relates to certain of such intellectual property consisting generally of trademarks, thereby creating a document appropriate for recordation in the United States Patent and Trademark Office of the United States.
- C. The Borrower and the Administrative Agent have agreed to amend the Supplemental Trademark Agreement in certain respects as set forth herein.

NOW, THEREFORE, in consideration of the foregoing Recitals and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto hereby agree as follows:

AGREEMENT

- 1. Replacement of Schedule 1 to Supplemental Trademark Agreement. Effective as of the First Amendment Effective Date Schedule 1 to Supplemental Trademark Agreement shall automatically be deemed amended and replaced in its entirety by Replacement Schedule 1 attached hereto.
- 2. <u>No Other Amendment</u>. Except as expressly amended hereby, the Supplemental Trademark Agreement shall remain in full force and effect as written.
- 3. <u>Counterparts</u>. This Supplemental Patent Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which when taken together shall constitute one and the same agreement.
