TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made by and among Hostess Brands, Inc., a Delaware corporation, by change of name, now known as Old HB, Inc., Interstate Brands Corporation, a Delaware corporation, and IBC Sales Corporation, a Delaware corporation all having a principal address at 12 East Armour Boulevard, Kansas City, Missouri 64111 (collectively "Sellers") and Flowers Bakeries Brands, LLC, a Delaware limited liability company, with its principal address at 1919 Flowers Circle, Thomasville, Georgia 31757 ("Assignee") effective as of July 19, 2013. Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the Agreement (defined below).

WHEREAS, Sellers, FBC Georgia, LLC and Flowers Foods, Inc. are parties to the Asset Purchase Agreement dated as of January 11, 2013 (the "Agreement") which was approved by the United States Bankruptcy Court for the Southern District of New York in an Order entered March 20, 2013 in Case No. 12-22052 (RDD) (the "Bread Sale Approval Order") and which provides for the execution and delivery of this Assignment;

WHEREAS, pursuant to the Agreement, Sellers have agreed to assign, sell, transfer, convey, grant and deliver to Assignee all of their rights to the Purchased Trademarks identified in Schedule 1.1(h) to the Agreement (which are also listed in Exhibit A hereto) but excluding, solely for purposes of this Assignment, those certain Twitter handles and domain names the transfer of which is evidenced by separate assignment instruments between the parties executed and delivered concurrently herewith (such Purchased Trademarks, the "Assigned Trademarks and Rights");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, on the terms and subject to the conditions set forth

in the Agreement, effective as of the Closing, the undersigned Sellers, and each of them individually, do hereby assign, sell, transfer, convey, grant and deliver to Assignee all of Sellers' right, title and interest in, to and under the Assigned Trademarks and Rights, including all registrations and applications for registration thereof, the goodwill of the business connected with the use thereof and symbolized thereby, all common law rights and rights of priority in any country in respect thereto, all rights arising from prior settlements or coexistence agreements with respect thereto and all rights of action, interests, claims and demands recoverable at law or in equity that any Seller has or may have for past, present or future infringements, thereof, in each case free and clear of all Liens (other than any Transferred Exceptions) and Excluded Liabilities

This Assignment is intended to implement the provisions of the Agreement, is expressly subject to the terms and conditions thereof, and shall not be construed to enhance, extend or limit the representations and warranties, rights, obligations or remedies of any party thereunder, and the Agreement shall not be superseded hereby or merged hereinto but shall remain in full force and effect. In case of any conflict or inconsistency between the terms and conditions of this Assignment and the terms and conditions of the Agreement, the terms and conditions of the Agreement shall govern.

The assignment of the Butternut Assets (as defined in the Bread Sale Approval Order) pursuant to this Assignment is subject to the terms of the Bread Sale Approval Order.

This Assignment will be governed by and construed in accordance with the federal laws of the United States and the laws of the State of New York applicable to contracts made and performed in such State.

This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will
