# SECOND AMENDMENT TO TRADEMARK SECURITY AGREEMENT

1. <u>Amendment to the Trademark Security Agreement</u>. Schedule I to the Trademark Security Agreement is hereby smended by supplementing Schedule I to the Trademark Security Agreement to include the information set forth on Schedule I attached hereto.

- (a) <u>Captions</u>. Section captions used in this Amendment are for convenience only and shall not affect the construction of this Amendment.
- (b) <u>Counterparts.</u> This Amendment may be executed in any number of counterparts and by the different parties on separate counterparts, and each such counterpart shall be deemed to be an original, but all such counterparts shall together constitute but one and the same Amendment. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.
- (c) <u>Governing Law</u>. This Amendment shall be construed in all respects in accordance with, and governed by, all of the provisions of the New York Uniform Commercial Code and by the other internal laws (as opposed to conflict of laws provisions) of the State of New York.
