## SECOND AMENDMENT TO TRADEMARK SECURITY AGREEMENT

This Second Amendment to Trademark Security Agreement, dated as of June 3, 2013 (this "Amendment") is by and between ATALANTA CORPORATION, a New York corporation ("Atalanta") and WELLS FARGO BANK, NATIONAL ASSOCIATION, as Assignee of COÖPERATIEVE RAIFFEISEN-BOERENLEENBANK B.A., "RABOBANK INTERNATIONAL", NEW YORK BRANCH, in its capacity as Administrative Agent for a group of Banks (together with its successors, "Agent")

WHEREAS, Atalanta and Agent are parties to that certain Trademark Security Agreement dated on or about February 15, 2006 (as amended, restated, modified or supplemented from time to time, the "Trademark Security Agreement");

WHEREAS, Atalanta and other Obligated Parties, Agent and the lender parties thereto entered into that certain Credit Agreement dated October 27, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"; capitalized terms not otherwise defined herein having the definitions provided therefore in the Credit Agreement; and

WHEREAS, Atalanta and Agent have agreed to amend the Trademark Security Agreement in the manner specifically set forth herein;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Amendment to the Trademark Security Agreement. Schedule I to the Trademark Security Agreement is hereby amended by supplementing Schedule I to the Trademark Security Agreement to include the information set forth on Schedule I attached hereto.

2. Miscellaneous.

(a) Captions. Section captions used in this Amendment are for convenience only and shall not affect the construction of this Amendment.

(b) Counterparts. This Amendment may be executed in any number of counterparts and by the different parties on separate counterparts, and each such counterpart shall be deemed to be an original, but all such counterparts shall together constitute but one and the same Amendment. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.

(c) Governing Law. This Amendment shall be construed in all respects in accordance with, and governed by, all of the provisions of the New York Uniform Commercial Code and by the other internal laws (as opposed to conflict of laws provisions) of the State of New York.

IN WITNESS WHEREOF, the parties hereto have duly executed this Second Amendment as of the date first written above.


