**TERMINATION OF TRADEMARK SECURITY AGREEMENT**

---

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT (this "Termination"), dated as of August 21, 2013, is executed by CHATHAM CAPITAL MANAGEMENT IV, LLC, a Delaware limited liability company, as Agent (the "Agent"), in favor of GYRO, LLC, a Delaware limited liability company ("Gyro").

A. To secure the payment, performance, and observance of the Obligations (as that term is defined in that certain Credit Agreement, dated as of May 14, 2012, and executed by Gyro, the other Credit Parties from time to time party thereto, Agent and the lenders party thereto), Gyro granted to Agent a security interest, pursuant to that certain Trademark Security Agreement dated May 14, 2012 executed by Gyro in favor of Agent and recorded with the United States Patent and Trademark Office on May 14, 2012 at Reel/Frame: 004779/0447, in the following collateral (the "Trademark Collateral"): (i) the trademarks, corresponding registrations and trademark licenses more particularly described on Schedule 1 annexed to this Termination and made part of this Termination for all purposes (the "Trademarks"); (ii) all reissues, continuations or extensions of the foregoing; (iii) the goodwill of the business connected with the use of, and symbolized by, the Trademarks; and (iv) all products and proceeds of the foregoing, including, without limitation, any claim by Gyro against third parties for past, present or future (a) infringement or dilution of any Trademark or (b) injury to the goodwill associated with any Trademark.

B. Agent now wishes to terminate the security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent does hereby terminate the security interest in the Trademark Collateral.
