**INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (FIRST LIEN)**

This INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (FIRST LIEN) is dated as of August 30, 2013 (the “*First Lien IP Security Release*”) and executed and delivered by Credit Suisse AG, as administrative agent and collateral agent (in such capacity, the “*Collateral Agent*”) for the Lenders and the Secured Parties (as such terms are defined in the First Lien Term Loan Credit Agreement dated as of February 29, 2012 (as amended, amended and restated, supplemented or otherwise modified through the date hereof, the “*First Lien Credit Agreement*”) among Credit Suisse AG, as administrative agent and collateral agent for the Lenders and the Secured Parties, DS Waters of America, Inc., as borrower, DS Waters Enterprises, Inc., as Holdings, the banks, financial institutions and other institutional lenders from time to time party thereto), in favor of DS Waters of America, Inc., DS Waters Enterprises, Inc. and Polycycle Solutions, LLC, (each, a “*Grantor*,” and collectively the “*Grantors*”). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the First Lien Guaranty and Security Agreement dated as of February 29, 2012.

WHEREAS, pursuant to a certain First Lien Copyright Security Agreement (the “*First Lien Copyright Security Agreement*”) dated as of February 29, 2012 each Grantor granted to the Collateral Agent a security interest in and to all of such Grantor’s right, title and interest in and to the Copyright Collateral (as defined in the First Lien Copyright Security Agreement);

WHEREAS, pursuant to a certain First Lien Trademark Security Agreement (the “*First Lien Trademark Security Agreement*”) dated as of February 29, 2012 each Grantor granted to the Collateral Agent a security interest in and to all of such Grantor’s right, title and interest in and to the Trademark Collateral (as defined in the First Lien Trademark Security Agreement);

WHEREAS, pursuant to a certain First Lien Patent Security Agreement (the “*First Lien Patent Security Agreement*”) dated as of February 29, 2012 each Grantor granted to the Collateral Agent a security interest in and to all of such Grantor’s right, title and interest in and to the Patent Collateral (as defined in the First Lien Patent Security Agreement);

WHEREAS, the First Lien Copyright Security Agreement was recorded with the United States Copyright Office on March 7, 2012 in volume 3613 document number 323, and the First Lien Trademark Security Agreement and the First Lien Patent Security Agreement were each recorded with the United States Patent and Trademark Office on March 2, 2012 on reel 4728 frame 0405 and reel 027795 frame 0523 respectively; and

WHEREAS, in accordance with a Payment Instruction and Release Confirmation Letter (the “*Release*”) dated on or about the date of this First Lien IP Security Release and given by the Collateral Agent, the obligations secured by the Copyright Collateral, the Trademark Collateral and the Patent Collateral have been repaid or otherwise satisfied to the extent set forth in such Release; and

WHEREAS, the Collateral Agent therefore desires to release its security interest in and to the Copyright Collateral, the Trademark Collateral and the Patent Collateral, including

without limitation the Copyrights, Trademarks and Patents identified in Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent and the Grantors hereby agree as follows:

SECTION 1. Release of Security Interest. The Collateral Agent does hereby release and convey to the Grantors, without recourse, representation or warranty of any kind, all of the Collateral Agent's right, title and interest in and to the Copyright Collateral, the Trademark Collateral and the Patent Collateral, including without limitation the Copyrights, Trademarks and Patents identified in Schedule A attached hereto. Without limiting the generality of the foregoing, the Collateral Agent hereby authorizes the Grantors (or any person or entity designated by the Grantors as its delegate for this purpose) to file any notices, terminations or amendments, as applicable with the United States Patent and Trademark Office, the United States Copyright Office or any Secretary of State that are necessary to effectuate, or reflect of public record, the release and conveyance described herein.

SECTION 2. Execution in Counterparts. This First Lien IP Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this First Lien IP Security Release by facsimile will be as effective as delivery of a manually executed counterpart of this First Lien IP Security Release.


