TRADEMARK SECURITY AGREEMENT

This Trademark Security Agreement (this "<u>Agreement</u>") dated as of September 10, 2013, is given by BODYBUILDING.COM, LLC, a Delaware limited liability company ("<u>Obligor</u>"), in favor of U.S. BANK NATIONAL ASSOCIATION, a national banking association ("Bank").

WITNESSETH:

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce Bank to extend credit to Obligor pursuant to the Financing Agreement, Obligor agrees, for the benefit of Bank as follows:

1. **Definitions**

Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided in the Financing Agreement and the Security Agreement.

2. Grant of Security Interest

Obligor hereby pledges and grants a continuing security interest in, and a right of setoff against, and effective upon demand made upon the occurrence and during the continuance of a Default or an Event of Default, assigns, transfers and conveys the Trademarks (including, without limitation, those items listed on <u>Schedule A</u> attached hereto) (collectively, the "<u>Trademark Collateral</u>") to Bank, to secure payment, performance and observance by Obligor of the Obligations.

3. Purpose

This Agreement has been executed and delivered by Obligor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to Bank in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The

4. Acknowledgment
