AGREEMENT AND PLAN OF MERGER

THIS AGREEMENT AND PLAN OF MERGER (this "Agreement") is entered into as of the 30th day of August, 2013, by and among Machine Solutions, Inc., an Arizona corporation (the "Buyer"), MSI Acquisition Corp., a Missouri corporation (the "Merger Sub"), Engineering & Research Associates, Inc., a Delaware corporation (the "Company"), and the "Principal Stockholders" who have executed this Agreement on the signature pages hereof. Capitalized terms used but not otherwise defined elsewhere in this Agreement shall have the meanings ascribed thereto in Appendix A attached to this Agreement and made a part hereof.

RECITALS

- A. The Merger Sub is a wholly-owned subsidiary of the Buyer.
- B. The Principal Stockholders executing this Agreement own beneficially and of record a majority of the issued and outstanding shares of capital stock of the Company.
- C. The Company is engaged in the business of designing, developing and manufacturing medical device manufacturing systems for the medical manufacturing and biopharmaceutical industries (the "Business").
- D. Each of the Buyer and the Company has considered the terms of the merger (the "Merger") as set forth in this Agreement and has concluded that the Merger is in the best interests of such party and its Stockholders.
- E. The Board of Directors of the Company has approved this Agreement and the Merger, and has recommended the Merger to the Company Stockholders, including, without limitation, the Engineering & Research Associates, Inc. Employee Stock Ownership Trust (the "ESOP"), and the ESOP and the Principal Stockholders have signed a written consent in lieu of a meeting to approve the Merger and other transactions contemplated by this Agreement.
- F. Each of the parties hereto desires to set forth certain representations, warranties, covenants and indemnity obligations made to induce the other to execute and deliver this Agreement and to complete the Merger and other transactions contemplated hereby.

AGREEMENTS

NOW, THEREFORE, in consideration of the recitals, the mutual representations, warranties, covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Buyer, the Principal Stockholders and the Company hereby agree as follows:

ARTICLE 1
TERMS AND PLAN OF MERGER

1.1 Merger and Effect of Merger.

(a) Entities Merging. The constituent corporations of the Merger shall be the Company and the Merger Sub.

(b) Effect of Merger. Subject to the terms and conditions hereof, at the Effective Time, the Company shall be merged into the Merger Sub and the separate corporate existence of the Company thereupon shall cease. The Merger Sub shall be the surviving corporation in the Merger (the "Surviving Corporation"), and the separate corporate existence of the Merger Sub with all its rights, privileges, powers and franchises shall continue unaffected and unimpaired by the Merger. At and after the Effective Time, the Surviving Corporation shall possess all the rights, privileges, immunities and powers and be subject to all the duties and liabilities of both the Merger Sub and the Company, as provided more particularly in The General and Business Corporation Act of Missouri (the "Missouri Corporation Law"), including without limitation Section 351.450 thereof. The parties intend that, for all Tax purposes, the Merger Consideration received by the Company Stockholders shall be treated as a liquidating payment by the Company to the Company Stockholders immediately following a deemed sale of the Company's assets to the Merger Sub.

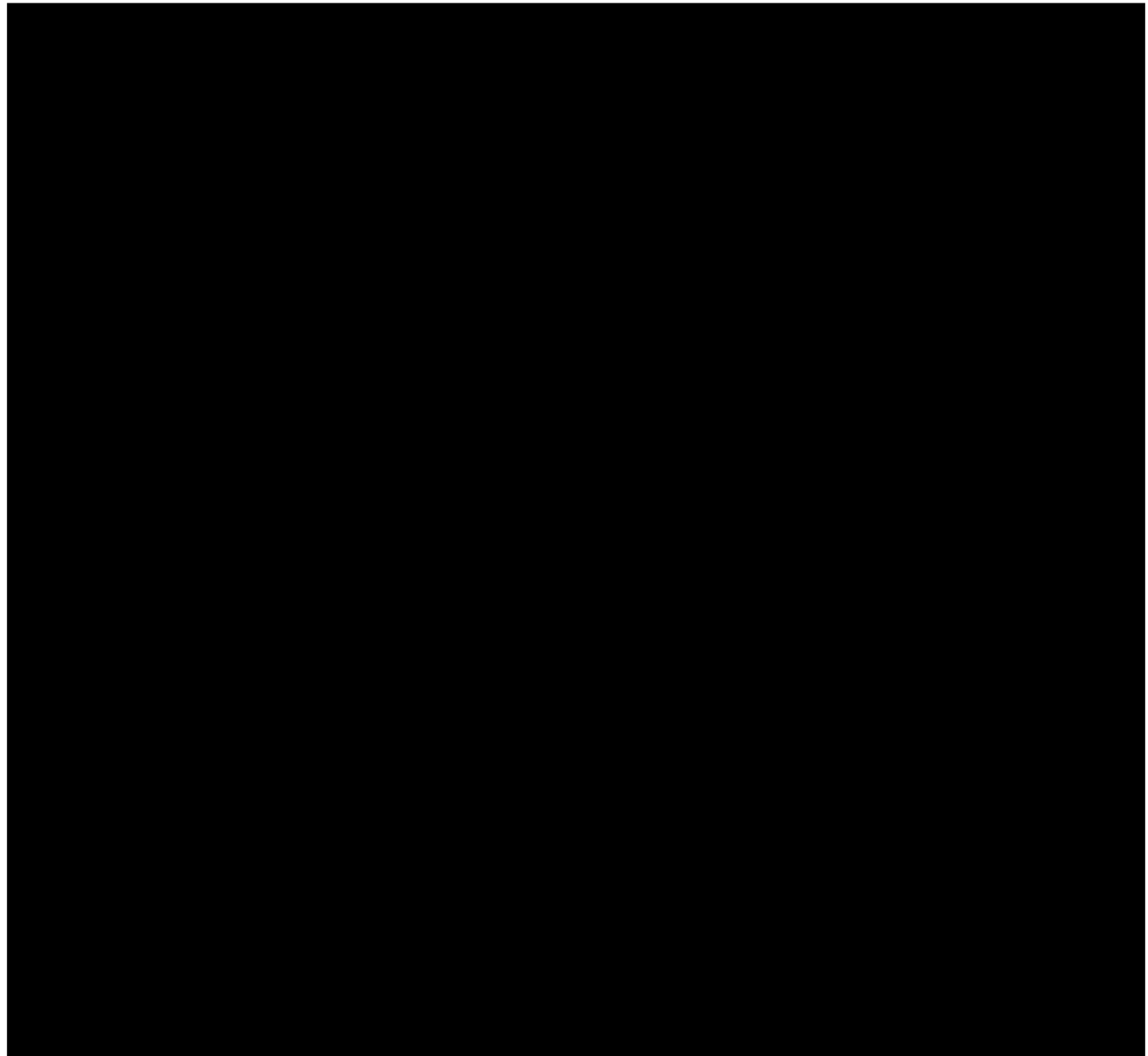
(c) Authority to Execute Documents. If, at any time after the Effective Time, the Surviving Corporation shall determine that any deed, bill of sale, assignment, assurance or any other action or thing is appropriate or desirable to vest, perfect or confirm of record or otherwise in the Surviving Corporation its right, title or interest in, to or under any of the rights, properties or assets of the Company and the Merger Sub acquired or to be acquired by the Surviving Corporation as a result of, or in connection with, the Merger or to otherwise carry out this Agreement, the officers and directors of the Surviving Corporation shall be authorized to execute and deliver, in the name and on behalf of the Company, the Merger Sub or otherwise, all such deeds, bills of sale, assignments and assurances and to take and do, in the name and on behalf of the Company, the Merger Sub or otherwise, all such other actions and things as may be appropriate or desirable to vest, perfect or confirm any and all right, title and interest in, to and under such rights, properties or assets in the Surviving Corporation or otherwise to carry out this Agreement.

1.2 Method of Effecting Merger and Closing. The Merger shall be effected as follows:

(a) Articles of Amendment and Merger. Promptly following execution of this Agreement, (i) Articles of Amendment and Merger, as contemplated by Section 351.458 of the Missouri Corporation Law, in substantially the form attached hereto as Exhibit A (the "Missouri Articles of Merger"), duly executed and acknowledged by the proper officers of the Company and the Buyer, shall be filed with the Missouri Secretary of State in accordance with the Missouri Corporation Law, and (ii) a certificate of merger, as contemplated by Title 8, Section 252 of the General Corporation Law of the State of Delaware (the "DGCL"), in substantially the form attached hereto as Exhibit B (the "Delaware Certificate of Merger," and, collectively with

the Missouri Articles of Merger, the “Merger Filings”) duly executed and acknowledged by the proper officers of the Company and the Buyer, shall be filed with the Delaware Secretary of State in accordance with the DGCL. The Merger shall become effective and be consummated as when provided in the Missouri Articles of Merger, and the stated effective date and time of such Merger Filings is herein referred to as the “Effective Time.”

(b) Closing and Closing Date. The closing (the “Closing”) of the Merger shall be deemed to take place at the St. Louis, Missouri office of Thompson Coburn LLP, commencing at 9:00 a.m. Central time on or about August 30, 2013, following the satisfaction or waiver of all conditions to the Closing (the “Closing Date”). The parties shall cooperate to exchange their Closing deliveries set forth in Article 3 through their respective counsel without the need for a physical meeting of the parties’ representatives.



4.13 Intellectual Property.

(a) To the Knowledge of the Principal Stockholders no computer software used, or products produced by the Company, infringes upon or violates any Intellectual Property rights of any third party in any material respect. To the Actual Knowledge of the Principal Stockholders, no third party has infringed upon, misappropriated or violated any Intellectual Property of the Company in any material respect.


(b) **Schedule 4.13** lists all registered and unregistered trademarks, service marks, trade names, copyrights, applications to register any of the foregoing, patents, patent applications and internet domain names of the Company and all license agreements to which the Company is a party (including both licenses from third parties to the Company of Intellectual Property owned or used by such third parties and licenses from the Company to a third party of Intellectual Property owned or used by the Company) material to the conduct of the business of the Company on the date hereof. Each license agreement required to be identified on **Schedule 4.13** is in full force and effect and (i) to the Knowledge of the Principal Stockholders, no party thereto has breached or is in default thereunder, (ii) to the Knowledge of the Principal Stockholders, no event has occurred which, with the passage of time or the giving of notice would constitute such a breach or default, (iii) no claim of default thereunder has been asserted or, to the Knowledge of the Principal Stockholders, threatened, and (iv) to the Knowledge of the Principal Stockholders, no party thereto is seeking the renegotiation thereof or substitute performance thereunder.

4.14 Title to Assets; Liens. The Company has good and marketable title to all of its inventory, accounts receivable, property, fixed assets, leasehold improvements and other assets and, except as set forth on **Schedule 4.14**, such assets are free and clear of any Liens, except for





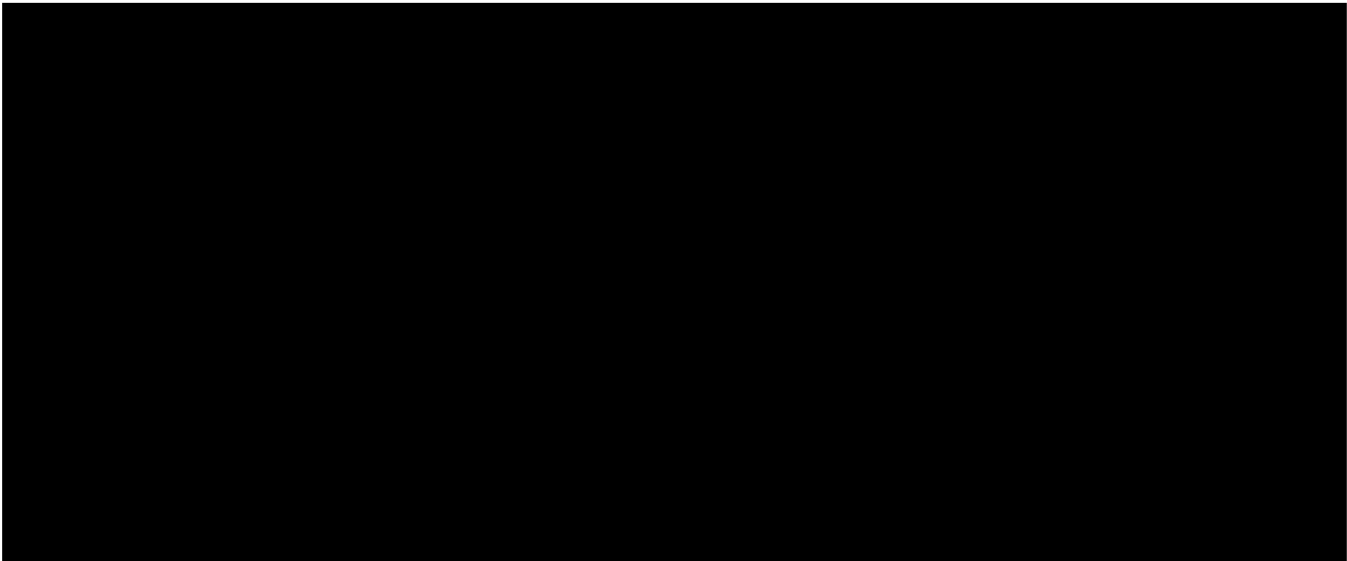
