## Trademark Assignment



Further, ASSIGNOR hereby authorizes and requests the United States Patent and Trademark Office to record this transfer of ownership to ASSIGNEE for its sole use, and for the use of its legal representatives and assigns, to the full end of the term for which such registration is granted, as fully and entirely as the same would have been held by ASSIGNOR had this assignment not been made.
