TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks, dated as of October 2, 2013 (the "<u>Termination and Release</u>"), is made by **DEUTSCHE BANK TRUST COMPANY AMERICAS**, a New York corporation, in its capacity as administrative agent (in such capacity, the "<u>Administrative Agent</u>"), on behalf of itself and the other Secured Parties for the benefit of **THE TOPPS COMPANY, INC.**, a Delaware corporation (the "<u>Grantor</u>"). Capitalized terms used but not defined herein shall have the meaning set forth in, or incorporated by reference into, the Security Agreement (defined below).

WHEREAS, pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement, dated as of October 12, 2007, between Tornante-MDP Joe Holding LLC, Tornante-MDP Joe Acquisitions Corp., The Topps Company, Inc., the Grantor and other Subsidiary Guarantors party thereto and the Administrative Agent (as amended, supplemented or otherwise modified prior to the date hereof, the "Security Agreement"), the Grantor pledged, assigned and granted to the Administrative Agent, under the terms of the Security Documents, a continuing security interest (the "Security Interest"), in favor of the Administrative Agent, in all of its right, title and interest in and to certain collateral including the trademarks and trademark applications set forth on Schedule A and the goodwill associated with the Trademarks (collectively, the "Trademarks") and all proceeds and claims based on past, present or future infringement;

WHEREAS, the Security Agreement related to the Trademarks was recorded on November 8, 2007 at the United States Patent and Trademark Office at Reel 003657, Frame 0319, and supplements to the Security Agreement were recorded on February 8, 2008 at the United States Patent and Trademark Office at Reel 003712, Frame 0227, and on November 2, 2009 at the United States Patent and Trademark Office at Reel 004089, Frame 0119;

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademarks and all proceeds and claims based on past, present or future infringement, as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the Secured Parties, hereby releases, terminates, cancels, re-pledges, reassigns and discharges any and all of its interest in the intellectual property of the Grantor, including, without limitation, the Trademarks, all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and all of the proceeds and claims based on past, present or future infringement, and assigns, transfers and conveys to Grantor any interest in such intellectual property and all proceeds and claims based on past, present or future infringement, including the Security Interest and any other liens. The Administrative Agent further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
