**RELEASE AND TERMINATION OF
SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Security Agreement (as heretofore amended, modified, supplemented and restated from time to time, the "Agreement") was executed by ARCTIC FOX, LLC, a Delaware limited liability company ("Debtor"), covering the patent and trademark registrations more fully described on Schedule I annexed hereto (collectively, the "Intellectual Property") and made a part hereof in favor of BMO HARRIS BANK NATIONAL ASSOCIATION, (as successor-by-merger to M&I Marshall & Illsley Bank, a Wisconsin banking corporation, itself as successor to Excel Bank Minnesota, a Minnesota state banking corporation) (the "Secured Party"), dated as of March 30, 2007, and certain security interests related to the Intellectual Property were recorded with the United States Patent and Trademark Office on April 2, 2007 on Reel 019094 Frame 0815. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Agreement.

Pursuant to a Payoff Letter dated as of March 23, 2012 (the "Payoff Letter"), Debtor paid the Payoff Amount to Secured Party (as defined in the Payoff Letter) and Secured Party acknowledged that all Collateral (as defined in the Payoff Letter) was deemed to be automatically released and terminated upon receipt of such payment, including with respect to the Intellectual Property.

The security interests relating to the Intellectual Property were not released and terminated at the time of the payoff of Secured Party and Debtor has now requested, and the Secured Party has agreed, to: (i) release and terminate the security interests in the Intellectual Property, (ii) record this Release and Termination of Security Agreement with the U.S. Patent and Trademark Office and (iii) discharge the Agreement.


The Secured Party hereby releases and terminates its security interest in all right, title and interest in the registrations set forth on Schedule I which were pledged and set over and otherwise made subject to a lien to the Secured Party by Debtor pursuant to the Agreement and terminates the Agreement in all respects.

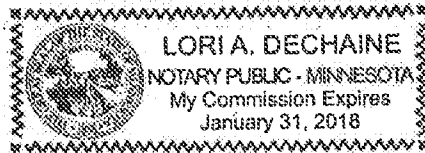
