RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is dated as of September 26, 2013 by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as collateral agent for the Lender and the Noteholders (the “Collateral Agent”), in favor of QUIKRETE HOLDINGS, INC., a Delaware corporation, THE QUIKRETE COMPANIES, INC., a Delaware corporation (formerly known as The Quikrete Companies, an Ohio corporation), QUIKRETE INTERNATIONAL, INC., a Delaware corporation, PAVESTONE, LLC, a Delaware limited liability company, QUIKRETE CANADA HOLDINGS, LIMITED, a British Columbia corporation (collectively, the “Borrowers”), SPEC/MIX, INC., a Minnesota corporation, and GIBRALTAR NATIONAL CORPORATION, a Michigan corporation (together with the Borrowers, the “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement , and if not defined therein, in the Loan Agreement.

WHEREAS, pursuant to the Third Amended and Restated Loan Agreement, dated as of January 3, 2012 (the “Loan Agreement”), among the Borrowers and the Lender, the Lender agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, the Borrowers and the Collateral Agent entered into that certain Third Amended and Restated Security Agreement, dated as of January 3, 2012 (the “Security Agreement”), pursuant to which the Borrowers secured their obligations to pay all obligations arising pursuant to the Loan Agreement, the Note Agreements and the Senior Notes.

WHEREAS, the Grantors and the Collateral Agent executed and delivered to the Collateral Agent that certain Third Amended and Restated Trademark Security Agreement, dated as of January 3, 2012 (the “Trademark Security Agreement”), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 2, 2012 at reel/frame number 4812/0624;

WHEREAS, pursuant to the terms and conditions of the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under the following, whether then existing, or thereafter created or acquired: (i) all Trademarks and Trademark Licenses of such Grantor, including those referred to on Schedule 1 and Schedule 2 hereto; (ii) all reissues, continuations, renewals or extensions of the foregoing; (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark and Trademark License; (iv) all income, royalties, products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future infringement or dilution of any Trademark or Trademark licensed under any Trademark License; and (v) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License (the “Trademark Collateral”); and


WHEREAS, the Collateral Agent acknowledges the satisfactory payment and performance of the Benefitted Obligations and desires to terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and forever discharges the Security Interest in the Trademark Collateral, and retransfers and reassigns to each Grantor any right, title or interest of the Collateral Agent in, to or under the Trademark Collateral of such Grantor.
