THIS AGREEMENT is made on the 9 day of September 2013.

BETWEEN

Anhui Light Industrial Import & Export Co., Ltd. of 19 Meishan Road, Hefei, Anhui, China ("Assignor")

AND

Anhui Light Industries International Co., Ltd. of 19 Meishan Road, Hefei, Anhui, China ("Assignee")

RECITALS:

A. The Assignor is the proprietor of the United States trade mark registration no. 2599997 for the mark "LILY with Chinese Characters " in class 16 ("Trade Mark Registration").

B. The Assignor wishes to assign the Trade Mark Registration to the Assignee and the Assignee wishes to take an assignment of the Trade Mark Registration.

OPERATIVE PROVISIONS:

1. In consideration of the payment to the Assignor by the Assignee of the sum of US\$10, the receipt of which the Assignor acknowledges, effective from the date of this Agreement, the Assignor assigns to the Assignee the Trade Mark Registration together with the goodwill in the Trade Mark.

2. Without limiting the generality of clause 1, the assignment of the Trade Mark Registration includes all entitlement to sue other parties and to obtain full and effective relief in respect of every act of infringement occurring prior to the date of this Agreement.

3. At the request of the Assignee, the Assignor will execute all such documents, forms and authorizations and depose or swear any declaration or oath as may be required for absolutely vesting full title and interest to the Trade Mark Registration in the Assignee.

4. This Agreement is governed by and construed in accordance with the laws of United States of America.

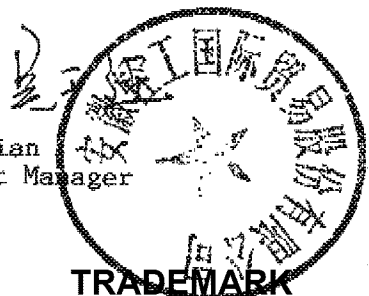
