## **NUNC PRO TUNC TRADEMARK ASSIGNMENT**

All covenants and obligations herein shall be binding on and inure to the benefit of the Assignor, Assignee, and their respective successors and permitted assigns.


Assignor hereby authorizes the Commissions of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to record this Assignment, and to issue or transfer said Trademarks to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Agreement.
