

rights associated with, owned, used or otherwise needed for the operation of the business of ASSIGNOR (hereinafter TRADEMARKS), together with the goodwill of the business symbolized by said TRADEMARKS, and together with all rights and privileges which are granted and secured by said TRADEMARKS, including, without limitation, all claims, demands and rights of action which ASSIGNOR may have had against others on account of any past infringement to sue for and obtain all relief to which ASSIGNOR may have been entitled by reason of any such past infringement, the TRADEMARKS to be held and enjoyed by said ASSIGNEE for its own use and benefit and for its legal representatives, successors and assigns to the full end of the term for which such TRADEMARKS are granted, as fully and entirely as the same would have been held by ASSIGNOR had this assignment and sale not been made.

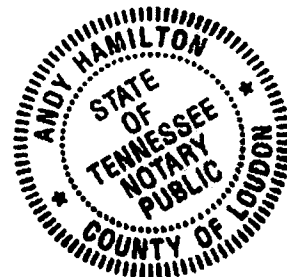
