1. The present corporate name (prior to any change effected by these Articles of Amendment) is "Riverside Products, Inc." (the "Corporation").


2. It is hereby resolved that ARTICLE I of the Corporation's Articles of Incorporation be deleted in its entirety and replaced with the following:

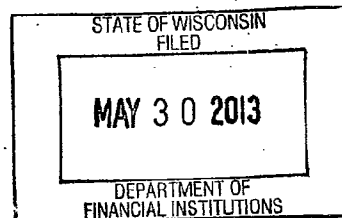
"ARTICLE I
