

Ezrani Corp., a Delaware corporation, does hereby certify:

FIRST: The names and states of incorporation of the constituent corporations to this merger are as follows:

Nina Footwear Corp.

SECOND: An Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 252(c) of the General Corporation Law of the State of Delaware.

THIRD: The name of the corporation surviving the merger is Ezrani Corp., except that at the time of the merger it shall be changed to Nina Footwear Corp. (the "Surviving Corporation").

FOURTH: The certificate of incorporation of the Surviving Corporation shall be amended and restated to read in its entirety as set forth in Exhibit A attached hereto.

FIFTH: The executed Agreement and Plan of Merger is on file at an office of the Surviving Corporation, 200 Park Avenue South #3, New York, NY 10003. A copy will be provided, upon request and without cost, to any stockholder of either constituent corporation.

SIXTH: The authorized capital stock of Nina Footwear Corp. consists of (i) four (4) shares of Class A Common Stock, without par value, and (ii) one thousand (1,000) shares of the Class B Common Stock, without par value.
