RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of November 1, 2013 in favor of Dispensing Dynamics International, a California corporation ("DDI") and San Jamar, Inc., a Wisconsin corporation ("SJI", f/k/a The Colman Group, Inc. and, together with DDI, each a "Grantor", and, collectively, the "Grantors") by PNC Bank, National Association ("PNC"), as agent (in such capacity and together with any successors in such capacity, the "Bank"). Unless otherwise defined herein, defined terms used herein shall have the meaning given to them in the Pledge and Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby, on behalf of itself and the Secured Parties, (i) terminates the Trademark Security Agreement with respect to the Released Trademarks, (ii) terminates, cancels and releases any and all security interests it has against the Released Trademarks, and (iii) re-assigns to the Grantors any right, title and interest it may have in, to and under the Released Trademarks.

The Bank shall, at the Grantors' expense, take all further actions, and provide to the Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
