FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Thermos L.L.C., a Delaware limited liability company (the "Grantor") with principal offices at 475 North Martingale Road, Suite 1100, Schaumburg, Illinois 60173, hereby grants HSBC Bank USA, N.A., as Administrative Agent, with principal offices at 95 Washington Street, 5th Floor NW, Buffalo, New York 14203 (the "Administrative Agent"), pursuant to the Security Agreement (defined below), a security interest in all of the following property, whether now owned or hereafter acquired or existing:

- (a) the United States trademarks and registrations and applications therefor set forth on <u>Schedule A</u> attached hereto (the "<u>Trademarks</u>"); <u>provided</u> that no security interest shall be granted in United States intent-to-use trademark or service mark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use applications under applicable law;
- (b) all of the goodwill of the business connected with the use of, and symbolized by, any item described in clause (a); and
- (c) all proceeds of, and rights associated with, the foregoing, including any claim by the Grantor against third parties for past, present or future infringement or dilution of any Trademark, or for any injury to the goodwill associated with the use of any Trademark.

THIS SECURITY INTEREST (this "Agreement") is made to secure the satisfactory performance and payment of all obligations of the Grantor under the Loan Documents, certain Lender Provided Hedging Agreements and certain Lender Provided Financial Services Products, as such terms are defined in the Security Agreement among the Grantor, Thermos Direct Response, Inc., a Delaware corporation, each subsidiary of the Grantor that becomes party thereto from time to time and the Administrative Agent, dated as of November 13, 2013 (the "Security Agreement").

Capitalized terms used but not defined herein have the respective meanings assigned to such terms in the Security Agreement. Upon request of the Grantor when all Liabilities have been paid in full and all Commitments have been terminated, the Administrative Agent shall execute, acknowledge and deliver to the Grantor an instrument in writing releasing the security interest in the Trademarks acquired under this Agreement. This Agreement may be executed in any number of counterparts and by the different parties hereto on separate counterparts, each of which when so executed and delivered shall be an original, but all of which shall together constitute one and the same agreement.
