## RELEASE OF TRADEMARK SECURITY AGREEMENT

This **RELEASE OF TRADEMARK SECURITY AGREEMENT**, dated as of November 8, 2013 (the "Release"), is made by Bank of America, N.A., as Administrative Agent for the Lenders (in such capacity, the "Administrative Agent"), in connection with the termination of that certain Trademark Security and Pledge Agreement (the "Trademark Security Agreement"), dated as of May 31, 2011, made by Exopack, LLC, Exopack-Technology, LLC and Exopack Advanced Coatings, LLC (the "Grantors") in favor of the Administrative Agent. All capitalized terms used in this Release and not otherwise defined herein shall have the meanings assigned to them in the Patent Security Agreement.

### WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement, the Grantors pledged and granted to the Administrative Agent, for the benefit of the Lenders, a security interest in all of the Grantors' rights, title and interests in, to and under the Trademark Collateral, including the registrations and applications listed on Schedule A hereto;

WHEREAS, the Administrative Agent acknowledges full payment, complete performance and satisfaction of all obligations secured by the Trademark Security Agreement;

WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in the Trademark Collateral in connection with the termination of the Trademark Security Agreement (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby RELEASES, without representation, warranty or recourse, all of its security interest in the Released Collateral, including without limitation the Trademark Collateral listed on Schedule A attached hereto and incorporated herein by reference.

The Administrative Agent agrees to, at their request, provide the Grantors with any information and additional authorization reasonably necessary to effect the release of its security interest in the Released Collateral, in each case, without representation or warranty by the Collateral Agent and at the sole expense of the Grantors.
