**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of November 25, 2013, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent for the Lenders (in such capacity, the "Administrative Agent"), in favor of SHFL ENTERTAINMENT, INC., FORMERLY KNOWN AS SHUFFLE MASTER, INC., a Minnesota corporation (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement (as defined below), or if not defined therein, in the Security Agreement (as defined below).

**WITNESSETH:**

**WHEREAS**, the Grantor is a party to that certain Security Agreement, dated as of October 29, 2010 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") pursuant to which Grantor executed and delivered that certain Grant of Security Interest, dated as of October 29, 2010 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement");

**WHEREAS**, pursuant to the Trademark Security Agreement, the Grantor granted to the Administrative Agent a security interest in all right, title and interest of the Grantor in and to certain trademark registrations and applications, including those listed on Exhibit A hereto (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks and the customer lists and records related to the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (collectively, the "Trademark Collateral"), to secure the prompt payment, performance and observance of the Secured Obligations.

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 4408, Frame 0688 on November 4, 2010; and

**WHEREAS**, pursuant to that certain Payoff Letter, dated as of November 25, 2013, between the Administrative Agent and the Grantor, the Administrative Agent has agreed to release the grant of its security interest in all of the right, title, and interest of the Grantor in and to the Trademark Collateral, and to reconvey any and all rights in the Trademark Collateral to the Grantor.

**NOW THEREFORE**, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby releases, relinquishes and discharges, with respect to the Grantor, all of its security interest in all of the right, title, and interest of the Grantor in and to the Trademark Collateral, and re-assigns to the Grantor any and all right, title or interest it may have in such Trademark Collateral, all without warranty or representation of any kind.

The Administrative Agent hereby authorizes the Grantor, or the Grantor's authorized representatives to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Administrative Agent in the Trademark Collateral.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed by its duly authorized representatives as of the day and year first above written.





