REVOLVING CREDIT FACILITY TRADEMARK SECURITY AGREEMENT**

**THIS AMENDED AND RESTATED REVOLVING CREDIT FACILITY TRADEMARK SECURITY AGREEMENT** (the "**Trademark Security Agreement**"), dated as of October 4, 2013, by each of **SOURCE INTERLINK MAGAZINES, LLC**, a Delaware limited liability company ("**Magazines**"), **CANOE & KAYAK, INC.**, a Delaware corporation ("**C&K**"), **SOURCE INTERLINK MEDIA, LLC**, a Delaware limited liability company ("**SIM**"), **AUTOMOTIVE.COM, LLC**, a Delaware limited liability company ("**Automotive**"), **MOTOR TREND AUTO SHOWS, LLC**, a Delaware limited liability company ("**Motor Trend**"), **GRIND MEDIA, LLC**, a Delaware limited liability company ("**Grind**"), **SOURCE MEDIA VENTURES, LLC**, a Delaware limited liability company ("**SMV**"), and **CARDOMAIN NETWORK, INC.**, a Washington corporation ("**CarDomain**"), and together with **Magazines, C&K, SIM, Automotive, Motor Trend, Grind and SMV**, each, a "**Grantor**" and collectively, the "**Grantors**"), in favor of **WELLS FARGO CAPITAL FINANCE, LLC**, as collateral agent for the Secured Parties (as defined in the Pledge and Security Agreement referred to below) (in such capacity as collateral agent, the "**Collateral Agent**").

**Witnesseth:**

**WHEREAS**, pursuant to that certain Amended and Restated Revolving Credit Agreement, dated as of the date hereof (as it may be amended, restated, replaced, refinanced, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), by and among the Grantors, certain Subsidiaries and Affiliates of the Grantors (together with Grantors, collectively, "**Borrowers**"), the lenders party thereto from time to time (the "**Lenders**"), Wells Fargo Capital Finance, LLC, as Collateral Agent and as administrative agent, Wells Fargo Bank, National Association, as Term Loan B Agent and certain other parties thereto, the Lenders have agreed to make loans to the Borrowers upon the terms and subject to the conditions set forth therein;

**WHEREAS**, pursuant to that certain Amended and Restated Revolving Credit Facility Pledge and Security Agreement, dated as of the date hereof (as it may be amended, restated, supplemented or otherwise modified from time to time, the "**Pledge and Security Agreement**"), by and among the Borrowers, certain other grantors party thereto and the Collateral Agent, the Grantors are required to execute and deliver this Trademark Security Agreement;

**WHEREAS**, subject to the terms and conditions of the Credit Agreement, certain Grantors or other grantors party to the Pledge and Security Agreement may enter into one or more Related Obligation Documents with one or more Approved Counterparties;

**WHEREAS**, (a) **Magazines, C&K, SIM, Automotive and Motor Trend** are a party to the Revolving Credit Facility Trademark Security Agreement, dated as of June 19, 2009, by and among **Magazines, C&K, SIM, Automotive, Motor Trend**, certain other grantors party thereto and Collateral Agent, (b) **Grind** is a party to the Revolving Credit Facility Trademark Security Agreement, dated as of October 29, 2010, by and between **Grind and Collateral Agent**, as amended, (c) **SMV** is a party to the Revolving Credit Facility Trademark Security Agreement, dated as of February 29, 2012, by and between **SMV and Collateral Agent** and (d) **CarDomain** is a party to the Revolving Credit Facility Trademark Security Agreement, dated as of September 26, 2012, by and between **CarDomain and Collateral Agent** (each, an "**Existing Trademark Security Agreement**", and collectively, the "**Existing Trademark Security Agreements**"); and

**WHEREAS**, in consideration of the extensions of credit and other accommodations of the Lenders as set forth in the Credit Agreement, each Grantor has agreed to secure such Grantor's

obligations under the Credit Documents and the Related Obligation Documents as set forth in the Pledge and Security Agreement and this Trademark Security Agreement.

**NOW, THEREFORE**, in consideration of the premises and the agreements, provisions and covenants contained herein and in the Pledge and Security Agreement, each Grantor hereby agrees with the Collateral Agent that the Existing Trademark Security Agreements shall be (and hereby are) amended and restated as follows:

1. Pledge and Security Agreement Definitions.

Unless otherwise defined herein, capitalized terms used herein (including the preamble and recitals hereto) and not otherwise defined herein shall have the meanings ascribed thereto in the Pledge and Security Agreement.

2. Grant of Security in Trademarks.

Each Grantor hereby grants to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, a Lien on and security interest in all of such Grantor's right, title and interest in, to and under all of the following personal property of such Grantor, in each case whether now owned or existing or hereafter acquired or arising and wherever located (all of which being hereinafter collectively referred to as the "**Trademark Collateral**");

- (a) all trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks, service mark applications, internet domain names and other source or business identifiers, including (i) the trade names, registered trademarks, trademark applications, registered service marks and service mark applications listed on Schedule 1 attached hereto and (ii) all renewals thereof;
- (b) all products and proceeds of Trademark Collateral, including all income, royalties, damages and payments now and hereafter due or payable under and with respect thereto, including payments under all licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof;
- (c) all rights to sue for past, present and future infringements and dilutions thereof;
- (d) the goodwill of each Grantor's business symbolized by the foregoing or connected therewith; and
- (e) all of each Grantor's rights corresponding thereto throughout the world.

3. Pledge and Security Agreement.

The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Pledge and Security Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. Counterparts.

This Trademark Security Agreement may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart so that all signature pages are attached to the same document. Delivery of an executed signature page of this Trademark Security Agreement by facsimile transmission, electronic mail or by posting on the Platform shall be effective as delivery of a manually executed counterpart hereof.

5. Governing Law.

THIS TRADEMARK SECURITY AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.

6. Amendment and Restatement.

(a) Each Grantor hereby acknowledges, confirms and agrees that, immediately prior to giving effect to this Trademark Security Agreement, (i) the Existing Trademark Security Agreements are in full force and effect as of the date hereof, and (ii) the agreements and obligations of such Grantor contained in the applicable Existing Trademark Security Agreement constitutes the legal, valid and binding obligations of such Grantor enforceable against it in accordance with their respective terms and such Grantor has no valid defense to the enforcement of such obligations.

(b) Except as otherwise stated in this Section 6, as of the date hereof, the terms, conditions, agreements, covenants, representations and warranties set forth in the Existing Trademark Security Agreements are hereby amended and restated in their entirety, and as so amended and restated, replaced and superseded, by the terms, conditions, agreements, covenants, representations and warranties set forth in this Trademark Security Agreement. Nothing contained herein shall impair or adversely affect the security interests, liens and other interests in the Trademark Collateral heretofore granted, pledged and/or assigned by each Grantor pursuant to the applicable Existing Trademark Security Agreement or otherwise. The amendment and restatement contained herein shall not, in and of itself, in any manner, be construed to constitute payment of, or impair, limit, cancel or extinguish, or constitute a novation in respect of, the obligations and liabilities of each Grantor evidenced by or arising under the applicable Existing Trademark Security Agreement (except to the extent any such obligations or liabilities are actually paid or performed on the date hereof), and the liens securing such obligations and liabilities, which shall not in any manner be impaired, limited, terminated, waived or released.




